WHILE IN NEW ORLEANS, LEE H. OSWALD APPLIED FOR AND WAS
ISSUED ~~NEW ORLEANS~~ PUBLIC LIBRARY CARD N ^{LOUISIANA} EIGHT SIX FOUR ZERO.
PRIOR INQUIRIES DEVELOPED OSWALD KNOWN TO HAVE PATRONIZED
NAPOLEON AVENUE BRANCH OF NEW ORLEANS PUBLIC LIBRARY.

INQUIRY DEVELOPED THAT NAPOLEON AVENUE BRANCH FOLLOWS
CHECK OUT SYSTEM OF SUCH A NATURE THAT TO DETERMINE WHETHER
A SPECIFIC PERSON HAD BORROWED A BOOK USING HIS LIBRARY CARD,
IT IS NECESSARY TO PHYSICALLY EXAMINE THE SO CALLED BOOK CARD
MAINTAINED IN AN ENVELOPE MOUNTED IN THE BACK OF THE BOOK.

ON NOVEMBER TWENTYSEVEN, INSTANT, JEROME CUSHMAN, LIBRARIAN, ADVISED FRED POWLEDGE, A NEW YORK TIMES REPORTER, HAD, BY RANDOM CHECKING, LOCATED SEVEN BOOKS WHICH HAD AT ONE TIME BEEN CHARGED OUT BY OSWALD.

ARRANGEMENTS HAVE BEEN MADE WITH MR. CUSHMAN FOR THE NEW ORLEANS FBI OFFICE TO TAKE CUSTODY OF THESE BOOKS WHICH ARE IDENTIFIED AS FOLLOWS.,
