Enclosed herewith is one copy of Secret Service report of SA ANTHONY E. GERETS and SAIC JOHN W. RICK at New Orleans, Louisiana for period November 23/27, 1963.

On Page 4 of enclosed report, JOE THOMPSON and GEORGE PLAZZA are referred to as acquaintances of LEE HARVEY OSWALD. Further, ANTHONY ATZENHOFF and JOHN CIRABOLO are referred to as possibly knowing OSWALD and DAVID WILLIAM FERRIE.

Interview of RGY TELL, Jr., 204 Zinnia Street, Metairie, Louisiana by SA W. J. DANIKLSON, Jr. on November 30, 1963, reflects TELL gave the names of ANTHONY ATZENHOFF, 2820 Cleveland Avenue, and JOHN CERAVOLO, as possibly having knowledge regarding OSWALD. Further, DAVID PEARCE MAGYAR, Chief Pilot, Trans-Gulf Seaplane Service, was interviewed November 27, 1963 by SA's WILLIAM A. NEWBROUGH and KEVIN J. HARRIGAN, at which time he said GEORGE PLAZZA, 539 Henry Clay Avenue, was one of DAVE FERRIE's best friends and could probably furnish information regarding FERRIE, and said PLAZZA was probably a member of the Civil Air Patrol at the same time OSWALD was alleged to have been a member.

It is also noted that on interview, FREDERICK O'SULLIVAN, 413 Heritage, Detective, Vice Squad, New Orleans Police Department, was interviewed on November 26, 1963 by SA's HARRIGAN and NEWBROUGH at which time he reported that he had learned that named individuals were members of the CAP possibly at the same time as OSWALD. One of the persons named by O'SULLIVAN at that time was JOSEPH THOMPSON.

It is noted the last sentence of Paragraph 9 reflects the Secret Service would attempt to locate and interview the persons referred to above.

New Orleans is requested to review their records regarding ATHZENHOFF, CIRABOLO, PIAZZA and THOMPSON, and if those persons have not been interviewed, reasonable attempts should be made to locate and interview those individuals for any information they may be able to furnish regarding OSWALD. It is noted there are variances in the spellings of the names of some of those persons, therefore, it is possible that there may have been interviews, and because of the variations in spelling, Dallas has not been able to locate pertinent interviews.
