Clearly apparent is that from the first there was executive agency withholding from the Commission and that to a sufficient degree it was aware of this.

Some of the errors can be attributed to this and to lack of knowledge for other reasons but not all. Nor all omissions.

Other FBI reports and one by INS were known and almost three months after the crime still not in WC possession. Hudkins and Goulden had not been interviewed and the recommendation that they be is timid at best.

The inherent incredibility of some of the FBI's story was perceived.
