SUBJECT: Lee Harvey Oswald Jack Ruby Dallas, Texas

On Friday, November 22, 1963, approximately 12:20 p.m., I viewed the Presidential Mateoreade at Harwood and Fraiste Avenue, Dallas. Thereafter I vent to a case for lunch. A short time later I learned that the President had been shot. I immediately returned to my office and listened to news reports over our radio system.

I called the U. S. Secret Service, the office of the U. S. Attorney, and the PNI - offering the services of the Intelligence Division. A short time later I received instructions from the office of the Assistant Regional Commissioner-Intelligence, to cooperate with the U. S. Secret Service, U. S. Attorney's Office, and the FBI.

I then asked my supervisors to keep their personnel on a stand-by basis.

About 3 p.m., Dob Stewart of U. S. Secret Service asked me to pull the 1962 income tax return of Lee Harvey Oswald. This was done shoot immediately. I was unable to reach Hr. Stewart by telephone and called Postal Inspector H. D. Holmes end told him that Oswald's 1962 income tax return showed original address as 602 Eisbeth, Apartment 2, Dallas, but that address had been marked out and Post Office Rox 2915 inserted. Mr. Holmes stated that was the first that he had heard of that box number in connection with Oswald.

The tax return indicated a refund of \$57.40 had been paid.

We caused a check to be made of the Director's records here, and then telephoned the Regional Disbursing Officer in San Francisco and obtained the number of the rotund check. This information was telephoned to Mr. A. R. Menzi, Assistant Director, Intelligence Division, at his residence. Later Mr. Menzi, clephoned Special Agent James II. DeFrato kint the check was Instering in Mechanicsburg, Fennsylvania, and that a U. S. Secret Service Agent out of Pittsburgh would proceed to Mechanicsburg and obtain the check. Later that night we learned that the check had been cashed at a liquor store.

Early Saturday morning, November 23, I went to the U. S. Secret Service Office and showed Dob Steuart the tax return of Lee Harvey Oscald which showed employment at Jaggare-Chiles-Stovall, 522 Browder; Dallas, and Leslic Helding Company, Fore Worth, and told him that I would have Special Agents Debroto and Tobert W. Klein check these places and get the Osvald Agents Teovis,
