Today I received from the Criminal Division the records referred to in its letter to me, one of what I'll enclose with this. Lil will make copies of some of the other records that for various reasons may be of a little interest. Much of what I'm not copying conists of letters to and from the Oswalds, Robert and Marguerite, having to do with LHO's property, etc., and Harguerite's theories.

After going over thos stuff I can't see any reason for any of it to have been withheld for lo these very many years.

Some of the claims to exemption made in the past may interest you for other litigation. like t e 5 claim for I think the word "silly."

I'll be writing them and I'll enclose my letter, too.

Some of this may have relevance in Mark's case. ,

One of the withholdings in the long memos relating to the phony "Mr. Hunt" letter is of the names of those who figured in a public trial by the DJ, the case in which Hirschkop represented them, the four case in which Fercy was involved.

I'm going to try to make more out in the handwritten memo that mentions my name in connection with the Archives. Maybe Idl's copies will be blacker. I did not get it or the other mention of me in the Hunt letter thing under PA, to the best of my recollection. Nor did I, again from recollection, get the basis for their accurate statement that I'd said that letter was a phony. Might be interesting.

Of course, to be certain I'd have to put these in their proper places in that large file and that is now impossible.

I also got that letter from Mexico City, as did others. I recall that Mo Waldron had the return addressed checked out. He asked me what I thought he'd found. I told him "safe house" and he agreed. My letter was not returned so unless they do not return misaddressed foreign mail, it was received by someone. I do not fecall getting the FBI's check referred to in the field offices case and because it originated in Dallas I should have gotten it or a paraphrase of it, which would have been sent to Dallas by the Legat, or FBIHQ.

I have all these Criminal Division records in a separate file cabinet, legal size, if you want to go over the others when you are here. This will all be in one folder, the last.

I don't know who they are referring to in the business of false information and the possibility of prosecution for giving it. Interesting that they considered such a step, huh?

Comstock was a NOPD assigned to Garrison. He did a black bag job on Ferris and turned the stuff over to the FEI, then had to go back for it when Carrison wanted it. Some of this is in my 0420 case affidavits. It included harcello defense information. Wassermann and G. Wray Cill were the lawyers.

2/11 Hopefully I ll be able to resume this soon but right now I'm quite uneasy about the tightness in the leg and thigh. I'm sorry that I've had to change the arragement reflected in my enclosed letter to Dave. It is not his fault. He tried for quite some time to get something in writing for me and in the end, and quite some time ago, I got only the unkept promises I refer to. I hope that this immediate megical problem is transitory that that I'll be in touch again soon.
