After denying that Oswald had been "attached "to the USMC Reserve unit listed on the Air Force form, I sent a follow up letter but this time with a copy of the form attached which had not gone out with the previous inquiry. The TTAF Form 20 is suppose to be Oswald's official student record at Keesler. Note that it list his last organization (Marine Air Detachment, Naval Technical Training Center, Jacksonville, Florida) from which he reported when going to Keesler. However, instead of listing the 4th Replacement Battalion, MCAS El Toro which was his next "official "assignment (Service records as published in the WC exhibits), it indicates (to me atleast) that after Keesler he was assigned to this Marine Reserve unit in Gulfport, Mississippi. This never before published document does not have him going to California where we are told the real Oswald was sent. What are your thoughts?

I trust that you enjoyed summer school in your new position as Cheif Honcho. And if you will, tell your two lovely ladies that I said hello.

By the way, I bought a copy of Ted Gandolfo's "book" COVERUP. What a drag! He cites on the cover that the book contains his recently aquired evidence and proof of direct C.I.A. involvement but I was unable to find it. Jerry didn't seem to hold Ted in too great esteem either. If you have not allready spent the money, save it for something else.

Have you anything on the Albert Schweitzer College? I wrote to the address in CE 236 but never got an answer. Perhaps in your educational capacity you could obtain a response and perhaps some literature. What do you think?

I'll probably go with the cryptography article for the September issue; it certainly is a matter worth raising in this forum, relating as it does to so much of the other "spy" indications from Oswald's effects. Of course I wonder, though, if some of this stuff wasn't planted precisely to give investigators the impression that LHO was a KGB agent. Since I'm so late on the July issue (in which your "weight of evidence" piece will appear), I think I'll assemble the September issue as well during the next week and mail the two issues together.

On the Keesler business, I want to hold off on publication until we can get some kind of explanation of that "attached to" notation on the training record. You mentioned in your last letter that Keesler denied that Oswald had been there. Isn't that different information than what we had before? It's one thing to deny that you've kept a record and another to deny that a person was ever there whom service records (maybe phony ones) show was there (including the "non-existent" one that you teased out of them). Please keep me informed on this.

You asked about Gandolfo's claim to "proof" of a CIA conspiracy. If you've had any personal dealings with TG, you'll know how everything is the latest and last word bombshell, as long as he or Garrison says it is. I made a disclaimer in THE THIRD DECADE about not vouching for the contents of any advertised materials, and I certainly don't want to vouch for anything claimed by Crazy Ted.

Dear Emory,

I received your Keesler AFB piece today, and was just in the process of getting to you the "weight of evidence" article as I've slightly re-written it. Please note, on the latter, that about all I've done is eliminate the personal questions to me from your letter; and also to put the references in the footnote format that I usually use. If you find any errors or problems with it, please let me know right away, as I'm going to put the July issue to bed (finally!) early next week.

On the Keesler thing, it's certainly revealing that the military could find a "non-existent" document because of your persistence; and maybe it's worth publication on that point alone. On the substance of what the record reveals: Oswald's "attachment" to a Gulfport unit of the USMCR, I have a little problem interpreting that as a post-Keesler assignment. Isn't it just as or more likely that, for some reason, Oswald and other trainees were "attached" to that unit for the duration of their schooling at Keesler? I mean, maybe the school itself was only a "faculty" responsible for technical schooling while someone else had to be responsible for the students' shoes being shined and the other "vital" things in a military existence; and maybe the reserve unit in Gulfport was simply the nearest Marine outfit that could serve that function. It is strange, on that interpretation, that Oswald's records don't show him transferred from Jax to that Marine unit rather than, as it shows, a transfer to the student training group (on one service record; the one you sent me shows him transferred to Marine HQ in Washington, the same outfit that gave him his orders to El Toro). There is no doubt in my mind that Oswald's service records have been seriously tampered with, if indeed phases of or his whole USMC career may have been paper-fabricated. Accordingly, it's worth pursuing the "non-existent" document as a slip-up in revealing an "unofficial" aspect of Oswald's Marine career. I don't want to go to print with it, though, until the "innocent" interpretation that I have suggested can be checked out. Any thoughts?

Thanks very much for remembering THE THIRD DECADE as you reflect over your completed and continuing assassination research.

OSWALD AT KEESLER; A Non-existant Document Surfaces by Emory Brown

Following his seperation from the 3386 Student Squadron at Keesler AFB in June 1957, Qswald took fifteen days leave before reporting to his next assignment which was the 4th Replacement Battalion, MCAS El Toro, California. That atleast is the official story as revealed in his service records contained in the exhibits of the Warren Commission Report(1). What is not published as a part of those exhibits and was officially non-existant untill I obtained it, is a document which indicates that Oswald may have been assigned elsewhere.

Initially, Keesler Technical Training Center had taken the position that they had no records for an individual named Lee Harvey Oswald and futhermore, had there been any such records, they would have been routinely destroyed ten years after the student had graduated from a given course(2). Such action was in keeping with Air Force regulations. Needless to say, I found it hard to believe that such records would have been "routinely" destroyed and also that the name Oswald didn't seem to ring any bells with anyone.

I took the liberty of sending a letter inwhich I explained who Mr. Oswald was and suggested that they dig a little deeper. That letter must have contained the right stuff for several weeks later an envelope arrived inwhich I found a one page copy of a formerly non-existant document and a very brief note saying that the enclosed was what I had requested. The document is an Air Force TTAF Form 20, which I was told was a copy of Oswalds train-

ing record. It is published here for the first time.

What is of particular interest about the document is the information contained in block 5 where it is stated that Oswald was attached to I&I 1st ArmAmphCo. USMCR, Broad Avenue, Gulfport, Mississippi! Why I wondered, would Oswald who had signed up for three years of active duty, have been assigned to a Marine reserve outfit after tech school? And, if the real Oswald was stationed in Mississippi, who was it that went to California to play the role of the misfit leftist?

A former marine at work told me that I&I ment Inspector and Instructor and that such a unit was responsible for providing additional training to new incomming personnel which were assigned to a military organization. However he said, he couldn't see a PFC as being an instructor since they almost always are NCOs or above in rank. His only explanation was that Oswald was a "gofer", a sort of erran boy but considering the training which Oswald had just received, I considered such duty unlikely. So, what is the answer?

Futher inquiries of the Commandant of the Marine Corps who had custody of Oswalds records according to the National Personnel Records Center in St. Louis, brought no reply. Could it be that someone inadvertently let this formerly non-existant document slip through a crack in the floor (shades of Fawn and Olie)? One can only wonder how much they have knowingly destroyed or " revised " or are holding back.




