As I am sure you are aware, there is nothing in the TTAF Form 20 which would indicate to a civilian such as myself. that the attachemnt to the Armor Company was for record purposes only. Through reading would not have revealed that and I as well as several others including former Marines have examined the document. Thank you for clearing the matter up for me and since it was such a simple answer I can only wonder why it took almost ten years from my initial inquiry in December 1977 to recieve the answer. Can you advise me as to what records would have been maintained by the Armor Company? There is no mention in the published Service Records ( Warren Commission ) of the Marine Reserve Unit.

There is one other matter which I would like to bring to your attention and that concerns a Mr. Daniel P. Powers ( SN: 1497089 ) a former Marine who attended school with Mr. Oswald at Keesler. Mr. Powers testified before the Warren Commission on 1 May 1964 ( see atteched ) and readfrom his travel orders from MAD NATTC Jacksonville to the 3380th TechTngGrp at Keesler, stated that he reported to the 3383rd Student Squadron for Course AB 27037 and upon graduation from same was awarded MOS 6747. Published records state that Mr. Oswald reported to the 3386th Stu-dent Squadrom for Course AB 27330 and was afterwards award-led MOS 6741. This would seem to indicate that although in s ed MOS 6741. This would seem to indicate that although in the same Class, they took different courses and graduating with the same Occupational Field Code, each had a different specific job title. Should I attach any significance to these differences?
