On 9/28/64, at 9:40 p.m., Night Supervisor NELSON NORFORD, Seat of Government, advised that the Bureau is desirous of knowing specific information contained in the assassination report submitted by the President's Commission. In substance, this report stated that Director HOOVER became concerned over the safety of OSWALD and sent a message to Chief of Police CURRY, Dallas, Texas, requesting that special care be given to the protection of OSWALD. This report also reflects that Chief of Police CURRY has testified that he does not recall ever receiving such message.

The Bureau desires to know if such a message was transmitted, when and where it is documented either in the Bureau or in the Dallas Office.

Extensive search was made of the Dallas Office based on this limited information and Night Supervisor BILL OSSMUS, Seat of Government, was advised at 11:15 p.m., 9/28/64, that no record could be located with this limited information.

At 7:37 a.m. on 9/39/64, Inspector MALLEY telephonically advised that the above assassination report contained the information that the message was relayed to Chief of Police CURRY on 11/22/64 through SA MANNING C. CLEMENTS. INSPECTOR MALLEY requested that Dallas Office make additional search in an effort to back up this testimony.

In addition, kyrise or MALLEY advised that the assassination report contained a region to on the same page, which had the names FRITZ, SORRELS, STEPHENS and CURRY. Inspector MALLEY does not know if this rootnote refers to the above statement, however, he requested the Dallas Office to make inquiry in an effort to determine this.

In addition, Inspector MALLEY made reference to the depositions furnished by SAs CLEMENTS and BOOKHOUT to the Commission on 4/6/64. He desired to know if the Dallas Office had retained a copy or if the United States Attorney's Office maintained a copy of these depositions. He stated that no open inquiry should be made.

A search of the Dallas files reveals the requested information concerning the transmittal of information to Chief of Police CURRY is contained in Dallas report of SA MANNING C. CLEMENTS dated 11/30/64, page 29.

At 8:43 a.m. today, Inspector MALLEY telephonically advised that the information desired had been located in the Bureau in above-listed report and that the Bureau desired no further action concerning this information or inquiry concerning the depositions.
