As you know, then ver I bear anything about your Cawald footage and what happened to it, I let you know. In this case, I ask that you keep this in confidence for a number of reasons, including that it is part of an ongoing, difficult and far from complete investigation I do plan to carry further. I am sending a copy to Sal Panzeca only, with the same request of confidentiality.

It has taken me from late 1968 until today to get a photocopy of the wrapper the Secret Service put on their print of your remaining footage. I told you the ensence of what it says. There was no legitimate reason for withholding it from me. Regulations, what it says, there was no legitimate reason for withholding it from me. Regulations, to the contrary, require that it be provided, as does the law. Not until the idea got accepted that if necessary I would again remort to the law (as I have, in court, three times, besides exhausting administrative remedies as a prelude to more) was it provided, this time with the pretense that it had been in the past. The fact is that in this came I think the Secret Service saw to it that it was provided. I forced them to deliver their print to the Archives, where it now is unless there has been a frame-by-frame comparison, in which event it was to have been returned to the Secret Service, the copy provided the warren Commission by the FBI in that event satisfying all overt needs.

Now I have never seen anyone in the still-existing footage you have and of which you were kind enough to let me have a copy, the FEI's copy or that of the Secret Service, that shows a third man "passing out circulars". I have FEI reports saying this of stills, as you know, for I sent you copies. I have descriptions of this missing man. As you also know, you footage as of the time you let me copy it does not contain all that remained after you footage as of the time you let me copy it does not contain all that remained after outtakes, for you and Jesse Core both remember seeing him in it. Jesse also remembers chasing that character, which it need not be paranoid to suspect may account for Jesse's disappearance from the footage, in whatever miraculous way.

Much time has passed, and at the time you had no reason to make special mental notes, or written ones. But I think it would be a good thing if you would, when you have time to think, make a not of all the people who ever had access to that footage beginning 11/22/63, and letting me know who and approximately whon. Today all copies are identical, yours, the FBI's and the Secret Service's. But the proof I have from both the FBI and the Secret Service is pretty solid that there was editing after you and Jesse at least ran it after 11/22/63.

On a subject that may interest Sal, in the still-existing footage is a man who can be taken to be Clay Shaw. I do not believe it is.
