Motive for this probably record-breaking stancealling and non-compliance appears to be obvious for each of the items of public information I requested at the least reflects on FEI failure, if not also deliberate suppression, in an important area, associates of less Servey Casald.

In all the many thousands of records I have examined I have yet to see any indication of any real effort to identify any devald associate in his New Orleans career. Instead it made an effort to pass off a Japanese importer as this other person.

I also informed you that the Trade Mart's public relations man, Jesus Core, told me of having reviewed the WDSU footage as soon as Casald was publicly identified. In another record in this file I have found what I regard as confirmation. He notified the FMI at 6:30 p.m. that MDSU had sant its footage to the net in Many York.

CHARLES HALL STEELE, JR., BORN NOVEMBER FIVE, FORTYTHREE, AT NEW ORLEANS, LA., APPEARED AT NEW ORLEANS OFFICE, NOVEMBER
TUENTYFOUR, IN COMPANY OF HIS FATHER, WHO IS A CIVIL DEPUTY SHERIFF
IN NEW ORLEANS, MAJOR IN THIRTYNINTH DIVISION, LOUISIANA NATIONAL

STEELE, JR. STATED ON FRIDAY, AUGUST SIXTEEN, SIXTYTHREE, HE WENT TO LOUISIANA EMPLOYMENT SEVICE, NEW ORLEANS, LA.,
A STATE AGENCY, WITH HIS GIRL FRIEND WHO WAS TO TAKE A TYPING EXAMINATION. WHILE WAITING IN THE RECEPTION ROOM FOR HER TO TAKE THE EXAMINATION, STEELE WAS APPROACHED BY AN INDIVIDUAL WHO STEELE BELIEVED TOLD STEELE, HIS NAME WAS OSWALD. OSWALD ASKED STEELE IF STEELE WOULD BE INTERESTED IN MAKING TWO DOLLARS FOR ABOUT FIFTEEN TO THEINTY MINUTES WORK IN DISTRIBUTING LEAFLETS. STEELE STATED HE AGREED AND MET OSWALD AT NOON IN FRONT OF THE INTERNATIONAL TRADE MART BUILDING., NEW ORLEANS, AT WHICH TIME OSWALD HANDED STEELE SOME, LEAFLETS TO DISTRIBUTE. STEELE, JR, STATED HE DID NOT LOOK AT THE LEAFLETS BUT BEGAN HANDING THEM OUT TO PASSERSBY AND WHEN HE HAD DISTRIBUTED ALL OF THE LEAFLETS HE RETURNED TO OSWALD WHO WAS ALSO END PAGE TWO

PASSING OUT LEAFLETS AND OSWALD GAVE STEELE A FEW MORE TO DISTRIBUTE. STEELE STATED HE THEN LOOKED AT THE LEAFLETS AND DISCOVERED THERE WAS SOME WORDING TO THE EFFECT QUOTE HANDS OFF CUBA UNQUOTE. STEELE STATED HE BELIEVED THE LEAFLETS TO BE COMMUNIST IN NATURE, THREW THEM IN A TRASH CAN AND TOLD OSWALD HE WANTED TO TALK WITH HIM. STEELE STATED HE AND OSWALD THEN WENT INTO THE FOYER OF THE INTERNATIONAL TRADE MART BUILDING WHERE HE ASKED OSWALD IF THESE WERE NOT COMMUNIST LEAFLETS AND WAS WAS ADVISED BY OSWALD THAT IT WAS A GROUP CONNECTED WITH TULANE UNIVERSITY.

STEELE STATED HE TOLD OSWALD HE WANTED NOTHING FURTHER TO DO WITH THE LEAFLETS. WAS PAID TWO DOLLARS BY OSWALD, AND DEPARTED.

STEELE, JR. STATED WHEN OSWALD MET HIM IN FRONT OF THE INTERVATIONAL TRADE MART BUILDING, OSWALD WAS ACCOMPANIED BY ANOTHER PERSON DESCRIBED AS WHITE MALE, NINETEEN TO TWENTY YEARS OF AGE, ABOUT SIX FEET, SLENDER BUILD, DARK HAIR, OLIVE COMPLEXION. STEELE STATED THIS INDIVIDAUL WAS DISTRIBUTING SOME OF THE LEAFLETS BUT DID NOT APPEAR TO HAVE ANY CONVERSATION WITH OSWALD AND IT WAS STEELS IMPRESSION THAT THIS PERSON HAD ALSO BEEN HIRED IN THE AME MANNER AS STEELE.
