Dear Mr. Hush,

When Paul hoch interviewed you e year ago, it was at my request. When Gerrison sent Bill Turner to see you, it also was because of me. I had been looking for you, chiefly to try and get copies of the stills of the footage you made of Cameld outside the Old ITM Bldg end gave to the federal agents. I got your parents' address, gave it to Sciembra, and he took it from there. I then had a print of the remaining footage. Et Planer made it available to me.

My interests are not diminished by the passing of time, so I write you, hoping that since kr. much spoke to you things may have come to mind. If there is anything you remember, it might be of considerable help, for this is one of the incidents in Swali's career the government has gone to greatest trouble to hide.

One of the intere ting things is that we have not been able to find my FBI report of an interview we to you, yet there is one of Bern Rotman being interviewed. You, not he, tookthese pictures. Do, it could be interesting to know who interviewed you and when, both at the time of the essessination and before. The FBI did investigate Cawald in her Orleans before the assassination, although they also nade efforts to withheld this from the Warren Commission. They did withhold their reports of it.

I have now located and examined what the Secret Service describes as the original film you took. This means after editing, as aired. It has clerity tending to make me believe they kept the original and returned a copy. They did not give this to the Commission. I am the first to examine it. Because they have this, I can only wonder why they gave the Commission a different copy. One of the possible reasons is to mide the identities of those with Oswald. The description with this film refers to two, but examination of it discloses but the onexamination of the known, Charles Steels, the young man in short. Have you any recollection of the second or other men with him?

I now have several elmost identical descriptions of one such men, a ting-American type, taller than Oswald, weighing about 200 pounds. One an earlier occasion, he was seen taking pictures of Oswald's distribution. Aside from the EWL man, do you recall any other photographer at the ITM?

Did you talk to Osweld or any of these men? If so, what did they say? You had lunch with Dolores Neeley. Did she say snything about this incident or those in your film? She knew some of them, including these from out of town. Do you know where she now is?

Did the fewerel agents select the frames to be printed? If so, mid they indicate any reasons for their selections? The Secret Service report, for example, says you provided 17 prints. And I have FMI reports of their showing six

different prints to witnesses. I do not see, in the existing footage, chough different film to cause 17 prints to be made, nor am I certain there are chough different sequences of relevance to the investigation to warrant six. If you could examine your existing footage again, perhaps it will suggest to you which stills you had printed and maybe sequences not now in the film. It may also recall what may have been in the outtakes.

Another possibility of interest is that the FBI interviewed you about this film shortly after you took it and before the assessination. The agent who then seemed most interested is Warran deBrueya, but I also ask you if one Wilton Kasck ever questioned you, or whether, to your knowledge, before the assessination, any agents asked to examine the gootage?

In short, almost anything you can remember about the film, Oswald and his possible associates can today be as significant as it could have been earlier. I would appreciate it if you could take the time to let me know whatever you do, no matter how trivial it may sound, for I do not believe you are in possession of the fact with which trivialities can fit and assume meaning.

Did you ever cover, have interest in or hear about either the Cuban comps in the area or enti-Castro activities? A WVUE photographer apparently visited at least one, made many pictures, and, after leaving New Crisans, seems to have disappeared. I can trace him to "inneapolis, where he opened a photo studio, after remarrying, to a woman from "inneapolis. His first wife was, I think, from Mississippi. If you know this man and how he can be reached, that can be helpful. I thinks he called his "inneapolis business Studio 120. To you know any other photographers who may have covered or made film of Oswald, Ferrie, or any of the above.

I do thank you for any help you can offer.
