REQUESTING INFO CONCERNING OSWALD/S ACTIVITIES AS ALLEGED

CHAIRMAN OF THE FPCC IN NEW ORLEANS.

IN APRIL, NINETEEN SIXTYONE, INQUIRY MADE OF ELEVEN SOURCES FAMILIAR WITH CUBAN ACTIVITIES IN THE NEW ORLEANS AREA FAILED TO REVEAL THE EXISTENCE IN NEW ORLEANS OF ANY GROUP OR ACTIVITY. WHICH MIGHT BE RELATED TO THE FPCC.

IN OCT., SIXTYONE, SIX SOURCES FAMILIAR WITH CUBAN MATTERS
IN THE NEW ORLEANS AREA, ADVISED THEY HAD NO KNOWLEDGE OF THE
EXISTENCE IN NEW ORLEANS OF ANY BRANCH OF THE FPCC.

ON AUG. NINE, SIXTYTHREE, LEE HARVEY OSVALD WAS ARRESTED

BY THE NEW ORLEANS PD WHILE DISTRIBUTING LEAFLETS ON CANAL ST.,

NEW ORLEANS, WHICH LEAFLETS INCLUDED AN APPLICATION TO JOIN

QUOTE THE FAIR PLAY FOR CUBA COMMITTEE, NEW ORLEANS CHARTER

MEMBER BRANCH, A. J. HYDELL, P. O. BOX THREE ZERO ZERO ONE SIX,

NEW ORLEANS, LA., UNQUOTE.

ALSO BEING DISTRIBUTED WAS THE BOOKLET QUOTE THE CRIME AGAINST

CUBA UNQUOTE BY CORLSS LAMONT. ON THE INSIDE OF THE BACK COVER

WAS STAMPED QUOTE FPCC, FIVE FOUR FOUR CAMP ST., NEW ORLEANS (22)

OSVALD ON INTERVIEW ON AUGUST TEN, SIXTYLHREE, DISPLAYED A WHITE CARD SHOWING OSWALD TO BE A MEMBER OF THE NEW ORLEANS CHAPTER OF FPCC, WHICH CARD WAS SIGNED A. J. HIDELL, AND A MEMBERSHIP CARD FROM FPCC, NEW YORK, DATED MAY TWENTYEIGHT, SIXTYTHREE, IN NAME LEE H. OSWALD, SIGNED V. L. LEE.

OSWALD CLAIMED HE HAD NEVER SEEN HIDELL BUT HAD SPOKEN WITH HIDELL ON SEVERAL OCCASIONS ON THE PHONE, THAT HIDELL HAD HAD A TELEPHONE BUT IT HAD BEEN DISCONNECTED. HE CLAIMED TO HAVE ATTENDED TWO MEETINGS AT WHICH THERE WERE ABOUT FIVEINDIVIDUALS, THAT HE HAD BEEN INTRODUCED TO THEM BY FIRST NAMES AND COULD NOT RECALL THE FIRST NAMES. ALSO CLAIMED ON ONE OCCASION HELD COMMITTEE MEETING AT HIS HOUSE BUT WOULD NOT ELABORATE ON THIS.

BUREAU REFERRED TO NEW YORK AIRTEL TO BUREAU DATED NOVEMBER
TWENTYSEVEN, SIXTYTHREE, ENTITLED FAIR PLAY FOR CUBA COMMITTEE,
NEW ORLEANS DIVISION, BUFILE NINE SEVEN DASH FOUR ONE NINE SIX,
SUB THIRTYTHREE, WHICH REFLECTS OSWALD WAS IN CONTACT WITH MR. LEE
OF FPCC OF NEW YORK.

ON NOVEMBER TWENTYSEVEN, SIXTYTHREE,

SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY, NEW ORLEANS PAREN PROTECT IDENTITY PAREN, DVISED AFTER A COMPLETE CHECK OF HIS RECORDS THAT THERE HAS BEEN NO LISTING IN THE NEW ORLEANS METROPOLITAN AREA FOR A. J. HIDELL BETWEEN JANUARY ONE, SIXTYTHREE, AND NOVEMBER TWENTYSEVEN, SIXTYTHREE, AND THERE HAS BEEN NO LISTING FOR A QUOTE FAIR PLAY FOR CUBA COMMITTEE UNQUOTE FOR THE SAME DATES. HE ADVISED THAT LOGICAL VARIATIONS OF THE NAMES A. J. HIDELL AND FAIR PLAY FOR CUBA HAD BEEN CHECKED WITHOUT LOCATING ANY PERTINENT RECORDS.

ON NOVEMBER TWENTYFIE, SIXTYTHREE, ELEVEN SOURCES, AND ON NOVEMBER TWENTYSIX. ONE SOURCE ACQUAINTED WITH SOME PHASES OF CUBAN

TO THE FAIR PLAY FOR CUBA COMMITTEE OR ANYONE BY THE NAMES

V. T. LEE, A. J. HIDELL OR KNOWN VARIATIONS THEREOF, OR UNDER THE

NAME O. H. LEE. NEWMAN VIEWED PHOTOGRAPH OF LEE HARVEY OSWALD AND

HAS NO RECOLLECTION OF SEEING HIM IN OR AROUND THE BUILDING AT

FIVE FOUR FOUR CAMP STREET, OR OF ANY INDIVIDUAL BY THAT NAME

CONTACTING HIM IN REGARD TO RENTAL OF OFFICE SPACE AT THAT ADDRESS.

WILLIAM K. STUCKEY, THE ROSS AGENCY, INC., FIVE TWO FIVE
GRAVIER STREET, CALLED AT OSWALD APARTMENT, FOUR NINE ZERO FIVE
MAGAZINE STREET, AUGUST SEVENTEEN, SIXTYTHREE, TO INVITE OSWALD
TO APPEAR ON RADIO PROGRAM. OSWALD SHOWED HIM MEMBERSHIP CARD IN
FPCC SIGNED A. J. HIDELL AND SAID THAT FROM HIS CONVERSATION WITH
OSWALD, CAME TO CONCLUSION THAT HIDELL IS A FICTITIOUS NAME OR
AN ALIAS USED BY OSWALD. STUCKEY ADVISED THAT IN A QUESTION AND
ANSWER PROGRAM IN WHICH OSWALD TOOK PART OVER RADIO STATION WDSU
ON AUGUST TWENTYONE, SIXTYTHREE, OSWALD SAID THAT FPCC WAS NOT
COMMUNIST CONTROLLED AND THAT HE, OSWALD, WAS A MARXIST.

ORLEANS, A TULANE UNIVERSITY GRADUATE STUDENT, ADVISED NOVEMBER
TWENTYSIX, SIXTYTHREE, THAT IN THE PAST HE HAS PARTICIPATED IN FPCC
ACTIVITIES IN NEW YORK CITY, WASHINGTON, D. C., AND SEATTLE,
WASHINGTON, AND HAS NEVER BEEN A MEMBER OF THE FPCC. SAID HE
ENGAGED IN NO ACTIVITY IN NEW ORLEANS IN FURTHERANCE OF THE AIMS OF
THE FPCC AND HE KNOWS OF NO FPCC ORGANIZED ACTIVITY IN NEW ORLEANS
NOW OR IN THE PAST. HE ADVISED THAT IN THE SUMMER OF SIXTYTHREE,
HUGH MURRAY, A GRADUATE STUDENT AT TULANE, TOLD HIM HE HAD PICKED
UP AN FPCC HANDBILL BEING HANDED OUT ON THE CAMPUS. THE NAME
A. J. HIDELL, P. O. BOX THREE ZERO ZERO SIX ONE, NEW ORLEANS, WAS
ON THE HANDBILL. ADVISED HE DOES NOT KNOW LEE H. OSWALD AND LEARNED
FROM THE NEWSPAPERS THAT HIDELL IS AN ALIAS OF OSWALD.

ON NOVEMBER TWENTYSIX, SIXTYTHREE, HUGH T. MURRAY, EIGHT NINE
TWO EIGHT DIXON STREET, ADVISED THAT IN MAY, SIXTYTHREE, HE WAS
A GRADUATE STUDENT AT TULANE UNIVERSITY, AND SAV A NUMBER OF
HANDBILLS, ONE OF WHICH WAS CAPTIONED QUOTE HANDS OFF CUBA UNQUOTE
AND THAT THE HANDBILL WAS UNDER THE SPONSORSHIP OF THE FPCC. HE
KNOWS OF NO ONE WHO SAW PERSON LEAVING HANDBILLS, DOES NOT KNOW
LEE H. OSWALD, JACK RUBY, A. J. HIDELL, OR O. H. LEE.

LAD ON NOVEMBER TVENTYSEVEN, SIXTYTHREE,

HE VENT TO OSVALD/S RESIDENCE FOR THE PURPOSE OF OBTAINING INFORMATION REGARDING THE FPCC TO TURN OVER TO AUTHORITIES. IN CONVERSATION WITH OSVALD, OSVALD STATED THAT HE, OSVALD, IS THE DELEGATE FOR THE FPCC IN NEW ORLEANS AND HE GAVE AN APPLICATION BLANK TO JOIN THE FPCC IN NEW ORLEANS.

AN INFORMANT OF THE NEW YORK OFFICE ADVISED SEPTEMBER TVENTYFOUR DASH TWENTYFIVE, SIXTYONE, THAT AN O. E. FAHACKER, SUBSEQUENTLY IDENTIFIED AS OLGA E. FABACHER, GEORGE LONGE AND CHARLES BAUGH, ALL WITH NEW ORLEANS ADDRESSES, WERE INCLUDED IN THE ADDRESSOGRAPH PLATES OF THE FPCC, NEW YORK CITY. THESE INDIVIDUALS INTERVIEWED AND ALL STATE HAVE NO KNOWLEDGE OF OSWALD OR ANYONE NAMED HIDELL.

CARLOS ZERVIGON, A TEACHER AT ST. MARIIN/S EPISCOPAL SCHOOL,
JEFFERSON PARISH, LA., A NEW ORLEANS SOURB, ADVISED HE HAD BEEN
INTERESTED IN JOINING THE FPCC AFTER HIS ARRIVAL KROM CUBA BUT HAD
NEVER HEARD OF A NEW ORLEANS CHAPTER OF THIS COMMITTEE AND HAD NEVER
HAD ANY CONTACT FROM LEE HARVEY OSWALD. HE STATED HE BECAME
DISENCHANTED WITH CASTRO PRIOR TO AUGUST, SIXTYTHREE, AND HAS MADE
NO EFFORTS TO CONTACT THE FPCC SINCE THAT TIME.

THAT HE DOES NOT KNOW OSWALD.

CHARLES HALL STEELE, JR., ADVISED THAT HE HAD BEEN AT THE LOUISIANA EMPLOYMENT SERVICE OFFICE FRIDAY, AUGUST SIXTEEN, END PAGE FIVE

SIXTYTHREE, WHEN HE WAS APPROACHED BY OSWALD TO ASSIST HIM IN ...
DISTRIBUTING SOME LEAFLETS FOR WHICH OSWALD WOULD PAY HIM TWO DOLLARS ACCORDING TO STEELE, HE DISTRIBUTED SOME LEAFLETS FOR OSWALD AND THEN WHEN HE DISCOVERED THE WORDING ON THE LEAFLETS, THREW THEM IN A TRASHCAN AND STOPPED HANDING THEM OUT. STEELE STATED AT THE TIME HE MET OSWALD IN FRONT OF THE INTERNATIONAL TRADE MART FOR THE PURPOS OF DISTRIBUTING THE LEAFLETS, IN ACCORDANCE WITH HIS PRIOR AGREEMENT, OSWALD WAS ACCOMPANIED BY ANOTHER WHITE MALE. STEELE GAINED THE IMPRESSION THAT THIS INDIVIDUAL HAD ALSO BEEN HIRED BY OSWALD IN THE SAME MANNER THAT STEELE HAD BEEN HIRED.
