Partin Conferences Recorded Tapes May Free Hoffa

Union Leader Corp. BATON ROUGE, La. — Municipal Judge William Hawk Daniels has admitted possession of tape recordings which could possibly win freedom for Teamsters President James R. Hoffa.

Judge Daniels, in an exclusive four-hour interview with this reporter and Ralph W. Sullivan, Boston lawyer, conceded possession of the recordings. "I have lots of tapes made in connection with the government's activities in the Hoffa case," he said.

Daniels told this reporter and Sullivan that he would turn over the tape recordings to the Union Leader after he "sorted the Partin-Hoffa tapes from others in my possession." The judge said when he left the district attorney's office he took "all the tapes in the office."

The Baton Rouge jurist said he personally made the tapes, using electronic eavesdropping devices hidden on his person. "I

am an electronics expert in my own right," Daniels said in explaining his use of the equipment.

According to Daniels, some telephone wire taps were made

with the knowledge of former FBI agents assigned to the Hoffa case by the late U.S. Sen. Robert F. Kennedy. Other tapes of conversations, according to the judge, "were made on my own without anyone's knowledge."

Daniel's involvement in the Hoffa case came to light in the wake of a deposition given March 27 in Sherman Oaks, Calif., by Edward Partin, a Baton Rouge labor leader. Partin's testimony was credited with convicting Hoffa on the charge of jury tampering.

Partin, in a 31-page deposition given before witnesses, said that in 1962 representatives of the Justice Department forced him into the role of informer by threatening him with a "hundred years in jail" unless he complied with their demands.

partment lawyer; Walter Sheridan, Chief of the Justice Department "Get H off a Squad"; and East Baton Rouge District Atty. Sargent Pitcher as being "in on the deal" whereby he was forced into being a "stool pigeon" against Hoffa.

Partin said he was ordered by Grimsley and Sheridan to infiltrate the Hoffa camp to learn the strategy of Hoffa's lawyers in what was known as the "test fleet case," a government suit against Hoffa in Nashville,

Tenn. A hung jury in this case resulted in Hoffa being charged with jury tampering.

Judge Daniels corroborated Patrin's accusations, saying, "as a special assistant to Pitcher, I was present during 'he meetings between Grimsley. Sheridan, Pitcher and Partin. I recorded some of these conursations without their knowle'ge. I have the tapes — I have a couple of boxes of tapes."

In his deposition Partin acrised federal agents and govriment lawyers of coaching him, instructing him nightly on ow to testify. "I was giving varjured testimony on their orders. I had no choice or they would have me in jail today," Partin told this reporter in an interview.

Partin went on to say that Sheridan and Michael Epstein of Washington, a special assistant to then Atty. Gen. Robert F. Kennedy, have been in constant touch with him since Hoffa's conviction.

"I have received protection and free legal advice from both Sheridan and Epstein since Hoffa was convicted. Every time some government official tries to prosecute me, these two, Sheridan and Epstein, come to my rescue and stop the prosecution," Partin claimed. This was substantiated by Gerald Gallinghouse, U. S

This was substantiated by Gerald Gallinghouse, U. S attorney in New Orleans. Gal linghouse, and his two top assistants, during interviews with this reporter, said they have definite knowledge that the two men have been protecting Partin since 1964.

"We can't get at the truth in the Partin-Hoffa matter. We are constantly thwarted by the Kennedy element remaining ir the Justice Department," saic Gallinghouse. His two assistants confirmed the U.S. attorney's statement.

Partin said he thought the "Kennedy gang" in the Justice Department had been removed. from office and that he could "finally tell the truth as to what really went on during the Hoffa investigation."

Partin went on to say, "Hoffa shouldn't really be in prison. I know I committed perjury, but I was forced into it by Kennedy's people. I'm willing to take my rap for perjury but I think the truth should come out."

Threats Claimed

Partin revealed that since his California deposition, he has been contacted by Sheridan and "threatened with all sorts of things happening to me. I wish someone could get him, and the other Kennedy people in the Justice Department, off my back."

Throwing a challenge to the federal judicial system and to congressional leaders in the House and Senate, Partin told this reporter, "I will testify, under oath before any congressional committee or any court official about the way in which the Hoffa investigation was conducted. I'll tell senators, judges or anyone else how things were done. Hoffa wasn't the only one the Kennedy gang wire-tapped or used electronic surveillance on." Witnesses to Partin's deposition were Patrick Willis of Los

Witnesses to Partin's deposition were Patrick Willis of Los Angeles, Dalton Smith and J. M. Walters, both friends of Partin. Irving Kramer, a Sherman Oaks lawyer, interrogated Partin with David Newman, a notary public, recording the testimony. A number of nationally known

A number of nationally known figures have become involved with the Partin deposition with film star and World War II hero Audie Murphy playing a key role. Murphy became involved through his close association

with Willis, a representative of an international business organization.

Murphy, winner of the Congressional Medal of Honor, and World War II's most decorated soldier, arranged for a copy of Partin's deposition to be delivered to President Nixon at the San Clemente summer White House April 7.

The film star also prevailed upon former U. S. Sen. George L. Murphy of California to personally hand-deliver a copy of Partin's deposition to Atty. Gen. John Mitchell.

Reporter Contacted

Willis and Murphy-contacted this reporter to request that he meet them in Los Angeles to discuss Partin's deposition. A copy of the document was furnished to this Union Leader reporter with the stipulation that nothing would appear in the press until such time as President Nixon and John Mitchell had time to review the document and take appropriate action.

Murphy, desirous of obtaining additional information, met this reporter in Dallas April 22 and 23 and conferred with Lester L. May.

May, a former U.S. attorney and a close personal friend of Murphy's, agreed to conduct a "more thorough examination" of Partin in an entirely new deposition.

However, because of the threats Partin claims are being made against him by Sheridan and other former Kennedy people still in the Justice Department, Partin is seeking assurances from someone "high in government" that he will receive protection from this group. "All I want to do is tell the truth now. I'm aware I committed perjury but I want to right the wrong I was forced to do," Partin said.

Murphy said the new deposition has not yet been taken, but he said, "I'm hoping we can get to it this week or next. I have met several times with Ed Partin, I'm convinced he is finally telling the truth and it is a shame the government won't allow the truth to finally come out in the open."

Governor Blamed

Partin. in an interview this week, blamed Louisiana Gov. John McKeithen for his troubles. saying. "It was Gov. McKeithen who made me the

patsy in this thing from the start. It was a move to get me out of the labor field so the governor and his henchmen could run things in Louisiana." Judge Daniels, in the interview with this reporter and Sullivan, even before Partin made his accusations against the Louisiana governor, said, "T am convinced the governor and Mr. Pitcher were out to get Partin from the very start - as long ago as 1062 when Partin first became involved with the law here."
