Ex-Castro Soldier Testifies in JFK Probe

WASHINGTON (AP) — Loran Hall, a former soldier for Fidel Castro who later turned against the Cuban leader, began secret testimony Wednesday before a House subcommittee on assassinations regarding the murder of President John F. Kennedy.

The panel went into closed session after Chairman Richardson Preyer, D-N.C., said Hall's testimony "may tend to degrade, defame or incriminate" other people without corroboration.

Hall has said in published and broadcast interviews that Dallas businessmen offered him \$50,000 to kill Kennedy several months before the President was assassinated in the Texas City Nov. 22, 1963.

and died within 90 days and 18 were stillborn, Golladay said.

The twins, born Sept. 14 at El Dorado in southern Arkansas, weighed 11 pounds, had one torso, two heads, two legs, two normal arms and a third arm with two hands attached to the wrist in a "praying hands" position, the doctor said.

Last June, Hall refused to testify to the assassinations panel, invoking his Fifth Amendment right against self-incrimination.

His lawyer said before today's hearing that Hall's cooperation would depend on whether the committee obtained for him court immunity from criminal prosecution for anything he said in his testimony.

The House gave the full committee on assassinations power last week to seek such immunity and Chairman Louis Stokes, D-Ohio, said it may be needed for some 150 witnesses.

A *Daily Journal* columnist has a taped interview in which Hall says the offer of \$50,000 to kill Kennedy was made by Dallas oilmen.

"We had to take all the doctors' expertise into consideration," he said. "Did this amount to some sort of manslaughter or homicide?" In our opinion, it did not, based on the Karen Quinlan case and others we cited. I have not had one call on this."

In other interviews, Hall said the offer was made by Dallas businessmen not otherwise identified, in one interview he did not describe who made the offer.

Subcommittee members fused to give any details of Hall's testimony today, but Del. Walter Fauntroy, D-D.C., said "he's talking." Asked whether Hall's testimony sounded credible, Fauntroy replied, "Well, I don't know. There are ways of checking it."

Hall also figured in other events surrounding the assassination, including an alleged meeting of Lee Harvey Oswald and two Latin two months before Kennedy's murder.

The Warren Commission concluded that Oswald killed Kennedy on his own

Hall told the Warren Commission he was one of three persons at such a meeting and that Oswald was not there, although a man who resembled him was. But Hall later said he was not at the meeting himself, either.

Former committee on assassinations counsel Richard Sprague has said that if Oswald were at the meeting, which supposedly occurred on Sept. 26, 1963, it would discredit CIA information that Oswald was in Mexico City on the same date trying to gain entry to Cuba.

Hall, born in the United States, once was a guerrilla fighter for Castro but later had a falling out and became an anti-Castro leader.

Parlin to Appeal His Conviction

SAN DIEGO, Calif. (AP) — Lawyers for Louisiana labor leader Edward Grady Parlin said they'll appeal his Tuesday conviction here on three counts of conspiracy to obstruct justice.

The trial was the eighth in a series of trials stemming from a 1973 indictment of Parlin and 11 other persons. They were charged with trying to hinder the investigation of labor union violence in New Orleans and Baton Rouge.

Parlin's attorneys labeled the government's charges "a seven-year horror story." They contend he is the victim of political persecution because he tried to get U.S. Attorney Gerald Callinhouse of New Orleans kicked out of office for allegedly harassing labor unions.

Parlin, 53, was accused of hiding out two witnesses against him in a 1972 obstruction of justice trial in Houston, Texas. He was acquitted in that case, which also dealt with an alleged threat against former
