I'm in the hospital for a few days and your letter was brought to me - Nothing to be alarmed about and I'll be out by the time you get this so don't be concerned about it at all - This is the only paper I could come up with.

Sounds like an excellent decision and buy on the Abai - Glad you got it and it sounds like it will serve your purpose very well.

Unless Jerry Polioff has gotten a copy of the transcript from somewhere else I don't believe you have it. It is 180 some pages long and is a transcript of the tapes made in New York City in the office of Melvin Wolf in the presence of James Wolf and Jack Moriarty of the H.S.A. and myself. Would you rather have the transcript or the tapes? I can make you copies of the tapes but if you want the 180 pages - I'll have to mail them to you for you to copy and then you can mail my copies back. Let me know.

Under a different cover I have mailed you a bunch of stuff which you may already have copies of - or at ~~least~~ least some copies of some of it. Please make copies of it and return my copies to me.
