1963, under scrial number 18479958, receiving an

PERSZ is acquainted with ESTMER ALVAREZ and her sister BEITRIZ ALVAREZ, having met them at Our Lady of Guadalups Church, Herwood Street, Dallas, PEREZ said during the past few weeks, Miss ALVAREZ has been unfriendly toward him and in fact has not even spoken to him for some reason which is unknown to PEREZ, PEREZ stated as far as he knew, he had not done anything to incur the omnity toward him and was at a loss to understand her present attitude toward him. He stated in the past he has been present on social cocasions when Miss ALVAREZ and Mrs. SEGURA were members of the group. He stated there was some discussion of the assassination of President KENNEDY which took place among the members of the group after the assassination occurred, however, all discussions were based on news received from the radio, television and the newspapers concerning this event. PEREZ aivised he has no knowledge of the assassination of President KENNEDY which took place mong the news media. He is not a member of any group in Dallas other than Chr Lady of Guadalupe Church. He does not own a pistol or any other type of gun and has never possessed a gun since residing in Dallas, Texas. He stated he was not acquainted with and had never seen LEE HARVEY OSVAID and did not attend any dinner or meeting at which CSVAID was measure. did not attend any dinner or meeting at which OSUALD was present. PEREZ denied making any statement to anyone present. PEREZ denied making any statement to sayone that he had been given a dangerous assignment and that his assignment had later been given to another person.
