

Gaeton Fonzi a former researcher for the House Assassination Committee which looked into the death of John F. Kennedy published an article in the Washingtonian Magazine in 1980. The article concerned Mr. Fonzi's efforts involved in getting to the bottom of the conspiracy behind the President's death. When asked by Fonzi if Phillips were Bishop, Veciana replied, "No, it is not him." Then added, "Well, you know, I would like to talk with him." This quote from the article stuck with me because it appears once again towards the end. This time Fonzi is visiting Veciana informally and asks him, "I would like you to tell me this one time very truthfully: Would you have told me if I had found Maurice Bishop?" Veciana's reply was,"I would like to talk with hime first." That statement coupled with the one made previous at the face to face meeting can be interpreted in two ways. The first being that Veciana would like to talk with Bishop first before identifying him, and this could be for his own protection or personal reasons, and there are many. Secondly, if the first reasoning is true, then one could almost assume that from Veciana's statement to Fonzi that Phillips is Bishop. Now more fuel for the fire. I understand that there is a legal suit

in the making involving Gaeton Fonzi, The Washintonian and David Phills I do not have details of the suit at this printing, but hope to find out facts concerning this within the next few weeks. People involved in this seem to suddenly die of natural causes or commit suicide. Strange isn't it.
