SUBJECT: ASSASSINATION OF

ReDallas airtel to the Bu, 11/22/63 (ser 249).

Supv. GEORGE BENJAMIN, Div. VI, was telephonically contacted at 8:40 PM and advised that the roll of 8 mm film furnished to the Bu for reproduction on 11/22/63, must be returned to Dallas tonight. He was advised that Secret Service had furnished this film and must have it tomorrow morning for a show-up.

Mr. BENJAMIN advised that he is not thoroughly familiar with it; however, he feels that due to the type of film it was necessary that it be produced commercially and he does not know if all action has been taken.

He was requested to advise us telephonically what action had been taken so that further steps to return film could be put into effect.

At approximately 9:35 PM, Mr. BENJAMIN advised the film will be sent via American Airlines Flight 691, leaving Washington at 2:50 AM, 11/26/63, due to arrive at Dallas, 5:45 AM. An Agent should contact the Captain.

Mr. BENJAMIN later advised the film would be sent via Braniff Airlines instead of American and would arrive in Dallas, 3:21 AM.

ASSASSINATION OF PRESIDENT KENNEDY

The following ^{four similar calls are} persons employed in the Texas School Book Depository were interviewed regarding any information they might have been able to furnish pertaining to the captioned incident and are as follows:

- Mrs. WILLIAM V. BARKER, 3916 Elsworth, 11/23/63;
- Mrs. MARY LEE WILLIAMS, 3718 Inwood Road, 11/24/63;
- Mrs. GEORGIA HENDRICKS, 2011 North Prairie, 11/24/63;
- Mrs. HERMAN M. CLAY, 6934 Casa Loma.

All of the above advised they had viewed the Presidential motorcade, however, could furnish no information of value concerning the assassination of the President and did not know LEE HARVEY OSWALD.

Mrs. MARY LEE WILLIAMS advised when shown a photograph of the Texas State Book Depository taken by a reporter from the Dallas Morning News on 11/22/63, that the individual observed standing in a window on the third floor with the blinds partially raised adjacent to Room 301 was her supervisor, Mr. STEPHEN WILSON, a white male.

On 11/24/63, LAWRENCE FORD, 303 N. Preswood, Garland, Texas, advised he is employed by WFAA-TV and Radio Station in Dallas and had been standing near the corner of Elm and Houston Streets and after the President had been shot, immediately ran into the Texas School Book Depository to make a telephone call to his place of employment and was not employed in that building, however, was stopped by police officer as he attempted to leave building. FORD was unable to furnish any pertinent information of value concerning the assailant of President KENNEDY.
