

by Harold Epstein Except for one dangerous slip of the tongue on the day that John Kennedy was murderd in Dallas, Deputy Sheriff Ed "Buddy" Walthers would probably still be alive and on the force today. He told newsmen that he saw a .45 caliber slug in the grass where the president's brains were lying. It is highly possible that that statement was to cost Walther his life a few years later.

The bullet was found in the grass across the street from a grass across the street from a manhold where Senator Ralph Yarborough said he saw smoke coming out immediately after Lee Harvey Oswald allegedly killed the president several hundred yards up and away from the motorcade. the motorcade.



The .45 is the standard military The 45 is the standard military handgun of the U.S. armed forces. The bullet is slow, traveling at 1200 feet per second, but is so heavy that after release from the muzzle it cuts the air, changing its spiraling. The spiraling pattern of a bullet is also called riffing, and is caused by six grooves in the barrel of the .45. The slug, simply stated, is so big that air contact is enough to make it wobble. When the already wobbling bullet strikes flesh, its uncertain orbit is thrown into total whack, creat-

ing a holy mess.
When "Buddy" Walthers saw
the bullet he was later to identify
as a .45, an unknown man
approached him and the city police who were at the scene and told Walthers to "get the fuck out of here" before Walthers picked the bullet up.

EX-WARREN COMMISSION STAFFER DEMANDS RE-OPENING KENNEDY CASE

A former staff member of the Warren Commission who is now a judge in Cleveland, Ohio, is calling for a reopening of the

calling for a reopening of the investigation into the assasina-tion of President Kennedy. Judge Burt Griffin, an attorney who questioned dozens of witnesses in the J.F.K. assassination case, says: "The case ought to be reopened... it's all tied in with everything that's been happening in our government for the past 10 years."

Griffin's views are spelled out in the current edition of "Rolling Stone" which contains 10 pages

of stories and photos relating to

the 1963 assassination in Dailas. Judge Griffin states: "I don't with us. I never though the Dallas Police were telling us the entire truth. Never was the F.B.I."

The former Warren Commis-The tormer Warren Commis-sion staff member says that six months after the investigation began, he wrote out a long memo to the investigation's director asking a series of what he thought were unanswered questions about possible loop-holes in the investigation and

about Lee Harvey Oswald. Griffin reports: "We only got answers to two or three of them."

New Times magazine reports that Cornell scientists are using computers to analyze the famous "Zapruder Film" he "Zapruder Film" is a home movie of the assassination filmed by Dallas dressmaker Abraham Zapruder who captured most of the assassination sequence on

Zapruder who captured most or the assassination sequence on his 8 millimeter movie camera. The procedure being used at Cornell is known as "image enhancement." "Image enhance-ment" is a process originally developed to clarify or "clean developed to clarify or "clean up" pictures beamed back to Earth by probes in space.

The process employs computers

images, often enabling research-rest to clearly identify objects in photographs that are badly blurred to the naked eye. The Cornell photo-analysts are said to be studying one particular frame of the Zapruder film—frame number 413. A number of Warren Commission critics in recent months have claimed that the frame contains a blurred but distinct image of a man pointing a rifle at President Kennedy's motorcade.

The figure in question—if it really is a man—is located on the grassy knoll where many Warren Commission critics believe the fatal shot was fired from.

Lee Harvey Oswald, an alleged leave stream was behind the

lone assassin, was behind the motorcade in a building, and was not on the knoll when the shots were fired. (ZNS)

POSSIBLE C.I.A. INVOLVEMENT IN KENNEDY ASSASSINATION? Senator Frank Church's Senator Frank

The Washington Post quotes a committee source as saying that investigators are "sniffing around on the J. F. K. assassination right

now."

The Post published a report earlier this year that the C.I.A. had been training a team of riflemen in Florida in the summer of 1963 to assassinate

summer of 1963 to assassinate Fidel Castro. President Kennedy personally intervened in that plot, and ordered the guns and weapons seized by the F.B.I. Investigators are believed to be looking into the possibility that this C.I.A.-trained rifle team might have turned against J. F. K. in revenge. (ZNS)

in revenge. (ZNS) TIME MAGAZINE ADMITS KENNEDY FILM WAS "NEVER ANALYZED"

Time Incorporated, the owner of the historic "Zapruder film," says it has never had that film of the John Kennedy assassination scientifically analyzed in search

for possible new evidence.

The "Zapruder Film" is a home movie of the assassination filmed 11 years ago by a Dallas dressmaker, Abraham Zapruder, who was in the area of Dealey Plaza when the shots were filed at the presidential motorcade.

at the presidential motorcade.

Immediately after the assassination, the film was purchased from Zapruder by the Time-Life Corporation. The film, which is copyrighted by the corporation, has never been shown publicly. with Time's permission.

However, investigators who have seen "bootlegged" copies of the film say that the movie itself disproves the Warren Commission's conclusion that Lee Harvey Oswald was the lone sesses. This is because the film assassin. This is because the film appears to show that President Kennedy was thrown violently backward and to the left as the final shot struck him.

Critics claim that the film demonstrates that the fatal shot came from the front right of the came from the front right of the motorcade, from the direction of the grassy knoll. Oswald was located directly behind the limousine, not to the front, when the final shot struck the president

A spokesman for the Time Corporation admits that, despire the firm's interests in journalism and investigative reporting, it has never subjected the movie to any kind of photo analysis. Time editors say they have never even analyzed the film to try to measure or explain the president's violent movement backwards.

The film today remains locked up in a vault at Time's corporate headquarters in New York. (ZNS) WARREN REPORT INFLATED—

In the past month alone, the price of the Warren Report has jumped from \$250 a set to \$500, New Times says. (ZNS)

ADDITIONAL MILITARY AID

ADDITIONAL MILITARY AID REFUSED THIEU GOVERNMENT The Ford Administration is blaming the military collapse of South Vietnam on the refusal of Congress to grant additional military aid to the Thieu government.

However, Long Island's Newsday newspaper reports that the alleged lack of U.S. weapons and supplies appears to have nothing at all to do with the defeats of

at all to do with the dereats of Saigon's forces in the fields. According to Newsday, Thieu government forces currently have at least twice as much ammunition and weaponry and at least five times as many armed soldiers in key battle areas as does the other side.

Newsday adds that administra-Newsaay agos that administra-tion reports that U.S. aid to Saigon is limited to \$700 million is misleading. The newspaper states that in addition to \$700 million in direct American military aid, the U.S. has sold the Saigon government an additional \$1 billion in U.S.-made arma-ments this year.

What's more, Newsday says, the
Pentagon has also been supplying additional U.S. arms and war
material to the South through a
system of "transfers." The system allows the Pentagon to send supplies to one country and then "transfer" them to South Viet-

Newsday says that the White House and Pentagon attempt to picture the Vietnam situation as the North being an overpowering "Gollath" overrunning the tiny
"David." The newspaper says:

PROSECUTOR QUITS ATTICA
INVESTIGATION—ALLEGES
COVER-UP
An assistant special Prosecutor
in the Attica Prison trials has
resigned his post in protest over
an alleged "cover-up" in the
Attica investigation in Attica investigation.

Attica investigation. Former prosecutor Malcomb Bell resigned last December, charging that his efforts to investigate crimes on the part of guards and other police were being blocked by state officials. Bell's letter of resignation which details alleged cover-up activities has been obtained by

Bell's letter of resignation which details alleged cover-up activities has been obtained by the New York Times. In that letter, sent to the New York State Attorney General last December, Bell alleges that a full and fair investigation into the Attica Rebellion would result in the indictment of law enforcement officers on murder, manslaughter and assault charges. Bell, who headed the investigation into police activities at Attica, says that Chief Prosecutor Anthony Simonetti prevented him from presenting evidence which was damaging to police agencies.

Following the Attica uprising, 62 persons- all of them inmates-were indicted on various murder and conspiracy charges. ZNS
