I just don't know really where to start, there are just so many questions I would like to ask you. However given your time limitations, I will limit myself to a few questions I hope you might have time to answer.

- ① Are the names and locations of the members of the assassination team in Dealey Plaza known to the critics? Are most still living?
- ② Are the names and locations of the major coordinators of the plot known to the critics? Are most still living?
- ③ Who is the real James Halpern? (Author Jewell America) Is it a team effort, if so, who are involved?
- ④ What do you think of the reliability of the book regarding the many hints that the "Committee" to assassinate the President met at certain places on given dates, etc. Does this critic have evidence to back up these statements? For example, book said Clay Shaw just an intermediate for the "Committee" to contact Lee Harvey Oswald etc. If so, why haven't these "facts" been given to reliable senators such as McGovern, Hughes, especially in light of RFK and King assassination and that evidence?
- ⑤ You were not very enthusiastic about the National Committee to investigate Assassinations. Have you seen evidence that things are looking up regarding this action group?
- ⑥ Have any critics published materials concerning JFK, RFK and Martin King since the Shaw trial other than Speague's articles in "Computers and Automation" and Los Angeles Free Press? If so, where might I obtain these?
- ⑦ If you are going to be at any meetings in Phila - Wilmington area this year, you're welcome to stay at my place if convenient to you.
- ⑧ What books in the last year do you feel are must reading concerning the assassinations?
- ⑨ Have you written anything since Oswald in No. 0 and answer to Epstein in Md. Mirror that I may obtain?
