I have now read it and assure you that it is. It is as vicious on Jim as the bewadcast. My need to read it was not personal. In part it was over this viciousness and in greater and certain part because it is disinformation, very hurtful disinformation. With all those "pressing matters" of state that weigh upon Four Highness you must have forgotten our discussions of this. Including the time you promised to send a dub of the tape on Tuesday. Meaning the coming Tuesday now at least two weeks in the past if not three.

When Jim has you for a friend he has no need of enemies.

And if I had not depended on your word I would have used other means to get a tape. Jim called you on this initially at my suggestion. But you were too self-centered to make more than one tape when you are equipped to.

I want you to know not only how I feel but what your undependability means. I ought not be working the hours I am again working. I am two full file cabinets behind in my reading of records I've obtained. Because all the self-important of decent income, of whom you are one, are better at using what Jim and I do than in helping do it or helping bear what for me is an enormous cost I have to make extensive copies for Jim because I can't afford the commercial costs. They are running \$100 a week or more and I have no regular income. It has cleaned out the little security I had from the sale of the H'town property. It is right for us to spend time this way and right for you to long-weekend every week and not do what little you can, like making tapes? I also have writing I want to do. I hear often enough from others that must do it. In but your time is. When I now get the tapes, with im back, I'll get even less sleep.

I don't know why you must be such a pig. but you are.

I assume you are telling me that Lane pays me special thanks in his book. If that is so (I haven't seen the book or galleys) it can only be to soothe his own ego as I did no more than supply him with my McMillan file. I asked only that he credit me with that material. I can assure you that Lane regards me as the "enemy" after I challenged him on several points on the Jerry Williams show and totally demolashed his friend Oltmans. Furthermore I couldn't care less whether you believe me or not. I'm tired of your recriminations, and I don't think I have to answer to you anyway.
