LEE RANKIN ENTITLED "OSWALD'S FOREIGN ACTIVITIES: SUMMARY OF EVIDENCE WHICH MIGHT BE SAID TO SHOW THAT THERE WAS FOREIGN INVOLVEMENT IN THE ASSINATION OF PRESIDENT KENNEDY" SAYS ON PAGE 111 "THE MOTIVE ON THIS WOULD OF COURSE BE THE EXPECTATION THAT AFTER THE PRESIDENT WAS KILLED OSWALD WOULD BE CAUGHT OR AT LEAST HIS IDENTITY ASCERTAINED, THE LAW ENFORCEMENT AUTHORITIES AND THE PUBLIC WOULD THEN BLAME THE ASSINATION ON THE CASTRO GOVERNMENT, THE CALL FOR ITS FORCEFUL OVESTHROW WOULD BE IRRESISTIBLE, A "SECOND WAVE OF PIGS INVASION" WOULD BEGIN THIS TIME, HOPEFULLY, TO END SUCCESSFULLY"

"THE FOREGOING IS PROBABLY ONLY A WILD SPECULATION, BUT THE FACTS WE ALL READY KNOW ARE CERTAINLY SUFFICIENT TO WARRANT ADDITIONAL INVESTIGATION"

THE ABOVE WAS WRITTEN IN THE SPRING OF 1964. I HAVE DOCUMENTS ESTABLISHING THAT THIS IS NOT "WILD SPECULATION" BUT THE ACTUAL MOTIVE FOR THE ASSINATION. I WILL DELIVER THESE DOCUMENTS AT YOUR CONVENIENCE.
