The anger in his eyes is obvious when Harold Weisberg, a national leading expert on the John Kennedy assassination, talks about a top-selling novel that attempts to end the mys-

tery surrounding the slaying.
Calling Gerald Posner's
Closed," released this released this "blatently dishonest," Mr. Weisberg wasted no time in countering the author's position that Lee Harvey Oswald killed President Kennedy. Mr. Weisberg came out with a novel of his own, released in April, called "Case Open," to prove Mr. Pozner's arguements wrong.

Like two lawyers, Mr. Weisberg and Mr. Pozner retried Oswald's case. Oswald was believed by the Warren Commission to have killed President John F. Kennedy.

Mr. Pozner's book claims to put to rest all other theories with proof that Oswald was the lone killer of President Kennedy. Mr. Weisberg said Mr. Pozner is just trying to sell books.

"Mr. Pozner can't tell the truth even by accident," Mr. Weisberg said. "In my book, I analyze and disprove every basic fact he said about Oswald."

Ironically, these battling authors used most of the same material and information to reach two very different conclusions about the assassination.

Mr. Pozner spent months at Mr. Weisberg's house outside of Frederick, going through the basement and study which are filled with informathrough the federal Freedom of Information Act.

"I make my information available to anyone who wants to look at it," Mr. Weisberg said, "Mr. Pozner didn't use all the information. He only used the information that supported his certain theory.

Mr. Weisberg's novel, "Case Open," refutes Mr. Pozner's claim that Oswald was the lone gunman.

"His book is written like the chief prosecutor's brief and mine is the commentary brief for the defendant. By only using official evidence, I prove that Oswald is innocent. That

he could not have committed the crime and the government knew it." Mr. Weisberg said sitting near a poster on his wall that shows Oswald holding a gun near a house.

Now 80 years old and battling heart and circulatory problems, Mr. Weisberg said he still believes it is his duty to set the record straight about the Kennedy assassination.

"I'm the first of my family born into freedom," said Mr. Weisberg who is of Russian decent. "I inherited my freedom and this gives me a chance to pay part of it back."

Although Mr. Weisberg said he is unsure of how many copies of his latest book were sold, he said his publisher said it was doing very well considering no money was spent to promote it.

With his latest book still on the shelves, Mr. Weisberg is back at the typewriter again.

He has finished another book called "Never Again." Instead of disproving someone else's theory about the Kennedy assassination, in this book Mr. Weisberg said he uses official evidence that the government ignored or misrepresented to prove that one person could not have done
