





he had already brought suit. On the other hand, the writer knows the lawyer who filed the suit for Boggs, and if there had been a chance to collect damages of one hundred thousand dollars, or even part of it, he would have insisted on trying the case

Now, I desire to tell the readers of the Federationist just what trouble I had to get a photostat of the suit against Boggs. For practically two months it was claimed the Index was lost and the Boggs suit could not be found. I had a young attorney look for the same, and it was only after receiving the docket No. from an outside source was I able to get copies of the suit.

Court records are public records; why should the index be lost? or how could the index be lost? Is it because someone wanted to cover up for Boggs? Could Boggs be sincere, when with great fanfare he brought his suit against Wimberly and WDSU and then let the case die. In discussing this with friends the thought was advanced that Wimberly did not have a hundred thousand dollars; but the suit was also against WDSU, and certainly they and the station's bondsmen have a hundred thousand dollars. 
