

I have been told that Martindale-Hubba^{ell}l for 1903 has the listings on Posner as in the current one except that the 1903 address listing is 521 Madison Ave.

If that was then the address of the William Morris Agency that would tend to confirm my suspicion that the address he gives is that of his agent if the current address, 515 Madison, is that of Pan Bernstein, who left Morris and set up her own agency.

He remained her client.

He used his middle initial in the 1903 M-H but does not in the current one ~~in~~ or in his current book.
