ASSASSINATION COMMESSION ABR: JMCM & BGR 9/46/64 While I join with my colleagues in the finding that there is mo clear and definite evidence connecting any person or group in a communicacy with Oswald to assassinate the President, there are some aspects of this case that I Fannot decide with absolute certainty due to the fact that any such evidence, if the exists, is beyond the reach of the Commission or the investigative agencies of the United States There are, however, several bits of evidence that have raised questions in my mind that are not answered or explained by any evidence the Commission could procure Among these are the extent of Oswald's associations and connections with the large number of Cuban Rationals who were students in the educational institutions in Minsk during his residence there; the mature and extent of his relationship with foreign mationals who may have had a purpose in washingtto Ell the President of the United States, the scope and humber of communications he may have had with Ξ.

ASSASSINATION COMMISSION 9/16/64 granted I do not share the finding of the Commission as to the proBability that both President Kennedy and Governor Connally were atruck by the same bullet. The expert testimony, based on measurements and surveys, including geenactment of the motortrip of the Presidential party on that faceful November 22nd presents a persuasive case.
