

Add to where Oswald was at the time of the shooting -1

With all the credible and official evidence proving that Oswald was not at that window firing those shots and could not have been and all of that credible, official evidence also disproving the entirely conjectured time he left that building and allegedly got to the scene of the Tippit killing, Posner wiped that problem for his book out with his usual phonying up a case by omission and by just plain lying.

As he twisted the truth about what Robert MacNeil and Carolyn Arnold said that is important ~~in~~ in placing Oswald on the first and not the sixth floor, Posner omits what the Secret Service itself said confirmed some of what Oswald said.

One of the strangest aspects of the "investigation" that troubled neither the Commission nor Posner is that with Oswald the only suspect in the assassination, when the police and various federal agents questioned him ^{none} ~~not one~~ had ^a ~~any~~ tape recorder and not a single page of any of the notes ^{those} the many questioners made exists. The purpose of the questioning was to get him to confess. ^{of} Wanting a confession, naturally the last thing the police or the federal agents wanted was to have the confession in his own voice. So, they not only had no tape recorder at any of the 14 hours of their questioning, they also saw to it that all their notes were memory-holed.

However, they did type and file reports. What we can know from the official evidence is limited to what was not omitted from those reports. From ^{their} ~~the~~ skimpiness of these reports most of those many hours ^{with} Oswald were passed in silence, there is that little in them.

Carefully as Posner manages to misrepresent it, those reports prove that on several vital elements of the evidence Oswald did say ~~what is exculpatory~~, what proves he could not have been the assassin. One of these elements of evidence ^d is where Oswald was and when he was there. He told his interrogators what he could not have known if he had not been there to see it or to participate in it.

One of the first of the Secret Service records to be made available at the National Archives, one that Posner makes no mention of, does confirm what Oswald did say that disproves the conjectured timing and also places Oswald on the first floor at a time that ~~disproves~~ destroys the official and Posner cases against him. ~~Not~~ In the Commission's ⁱ files it is in No. 354. Here is how it begins:

He asked the man if he was all right; the man stated that he was. Allman then ran up an incline toward Houston Street. Upon reaching the top of the incline, he turned and ran down. He stated that he is at a loss to explain this action other than he was extremely excited and upset by the assassination.

Mr. Allman then stated that he ran full speed into the Texas School Book Depository Building with intention of locating a phone and calling his television station WFAA. Driving to pick his wife up,

"Bowley saw the police car and the people around it. He drove there and stopped. His affidavit then says, "I looked at my watch and it said 1:10 pm."

This refutes both the Commission ^{Report} and Posner's ^{book} effort to validate its conclusion.

~~What~~ What follows is confirmation of what Allman said by Terrence Ford, ~~WFAA's~~
WFAA's radio promotions director, who was with Allman.

Under "DISPOSITION" the Secret Service wiped this all out with what is a non
sequetur in the assassination investigation, that although these were the men Oswald
had said he had spoken to and told where to find a phone, because "there is no indication
that they identified themselves as Secret Service Agents, this phase of the investi-
gation is closed"!

Oswald has an exculpatory alibi and ~~the case~~ that "case" is "closed", ^{This exculpatory alibi since} and ^{is then} it is

If Posner and the other apologists for the whitewash and cover-up described as the

Reference is made to previous reports relative to Lee Harvey Oswald.

Other Investigations

On 11-22-63 the following was reported to SAIC Forrest V. Sorrels, by Captain Will Fritz, Dallas Police Department.

Lee Harvey Oswald in the first interview subsequent to his arrest, stated that as he was leaving the Texas School Book Depository Building, two men (one with a crew cut) had intercepted him at the front door; identified themselves as Secret Service Agents and asked for the location of a telephone.

On 1-1-64 Mr. Jack Brian, Detective, Dallas Police Department, stated that he had interrogated Mr. James Powell, Army Intelligence, who was trapped inside the Texas School Book Depository after the Depository doors had been sealed.

On 1-28-64 Mr. Powell was interviewed relative to his location at the time of the assassination and his actions subsequent to the assassination. Mr. Powell stated that he had been watching the parade from a position near the corner of Houston and Elm Streets, the site of the assassination. Mr. Powell stated further that he heard the shots and he then joined a group of Sheriff's Deputies, who were heading toward the rear of the Texas School Book Depository on the basis of information that the assassin had shot from the railroad yards. worked with the Sheriff's Deputies at the rear of the Texas School Book Depository for about six or eight minutes. He then entered the front door of the Depository, in search of a phone from which to call his office. Mr. Powell, upon entering the Texas School Book Depository, observed Mr. Pierce Allman using a phone in the lobby of the building. Mr. Powell stated that he did not meet anyone upon entering the building nor was he called upon to identify himself to anyone. Mr. Powell stated that the only persons present on the first floor of the building at the time of his entry were Mr. Allman and an unidentified white male described as being tall and about 30 years of age; both of these men were near a desk in the lobby and Mr. Allman was using a telephone.

Mr. Powell has submitted a report of his activities immediately subsequent to the assassination of the President and states that his report will be available to this office upon request.

On 1-29-64 Mr. Pierce Allman was interviewed at his office in the WFAA T-V building where he is employed as Program Director. On January 31, 1963, Mr. Terrence Ford, Radio Promotion Director, WFAA, was interviewed relative to his actions subsequent to the assassination.

Mr. Ford stated that he had accompanied Mr. Allman to the corner of Houston and Elm Streets to watch the procession; that upon hearing shots, he retreated to a concrete building near the side of the small park bordering Elm Street, then running back toward the Texas School Book Depository. He followed Allman into the building, walking on his right side. He remembers Allman turning to his left to ask a white male the location of a telephone. Ford stated the white male, whom he can neither identify nor describe, indicated in some manner that a telephone was inside a room directly ahead. Ford does not remember Allman identifying himself at this time. Ford stated that he did not have a press card at this time and did not identify himself to anyone until he left the building about one hour later.

Ford has seen pictures of Lee Harvey Oswald and states he cannot remember if Oswald was the man he and Allman met at the front door of the Texas School Book Depository.

DISPOSITION

The facts surrounding the entrance of Allman and Ford into the Texas School Book Depository indicate that they are the men referred to by Oswald in his interview with Captain Fritz. In view of this and of the fact that there is no indication that they identified themselves as Secret Service Agents, this phase of the investigation is closed.
