Dear Hal:

I had a chance to go over my notes and bring you further up to date with respect to my recent visit to Dallas plus some additional items on Oliver Stone which you wanted me to send you if I came across them.

The enclosures I've included deal with the Dallas Symposium, Oliver Stone's movie plus some interesting book reviews (Mark North's book on J. Edgar Hoover and a review of a new book on Meyer Lansky). I think the "Texas Monthly" Dec. 1991 story is an important one. You may not have seen it so I'm sending it to you. Notice that one of the enclosures I sent is a piece by Tom Bethell on the Stone film.

I know I had promised you a listing of all of Oswald's Marine Corps associates, I've managed to list but I can't be able to include it in this letter (it would take too long to put it into a form where it can be easily referred to. I also want to have it put into alphabetical order so it can be readily referred to. I will be working on completing it sometime this coming week (I have a note on my desk to complete it + send it off to you so it is a task that I will get done!).

Speaking about lists I just received a "Master Researcher Directory" dated November, 1991. It is put out by Gordon Winslow out of Miami. My name and Paul Hoch's name are in it. It contains 213 names and one surprising

I know and that is this: Apparently Perry & Frazier have gotten to be very good friends (Perry told me they often go to ball games together). I knew, of course, that Frazier owned a British 303 rifle and that Frazier, of course, was interrogated soon after the assassination.

But what I didn't know as Perry explained to me was that Frazier was called back for further questioning. The second interrogation was more intense and Frazier kept saying to Frazier something like: "C'mon boy tell us what you know. Tell the truth, boy!" Frazier, according to Perry, got real scared at that point and thought he was being singled out as the assassin.

It is Perry's belief that Frazier who was only 19 at the time (1963) was under tremendous pressure & the story about Oswald bringing in a long bag was really a "white lie" made up (to protect Frazier). Perry told me that it was Frazier's sister who pointed out the bag to her brother & that he (Frazier) actually didn't see the bag Oswald allegedly had with him. The bag was in the back of the car as Perry pointed out. Perry said, nevertheless, that Frazier held firm as to the size of the bag.

I guess you'd have to write to Perry & ask him for precise details on this.

I have already given you Stan Szerszen's address & phone# (in my last letter). One thing I forgot to tell you about him is that he got to speak with Kennedy aide, Dave Powers. Powers told Szerszen that he knew that shots came from different directions when he was in the motorcade & everyone who was with him also knew it.

Bett, said Powers, if the contents of this particular conversation were made public he told Szerszen that he would totally deny it!

By the way I've written Szerszen & asked him to write you about his analysis of the Tom Wilson photo "evidence." I hope he will do so.

An interesting thing I forgot to mention in my last letter (I looked over my notes) is that when I was getting off the elevator at the Dallas hotel Regency (Hyatt) & going to my room there was a gentleman getting off the same floor as I was and he had a name tag showing the last name "Carr." I jokingly said to him, "You're not related to a Mr. Waggoner Carr" and to my great surprise he said, "Why, yes - he's my brother." I then asked him why he was attending & he told me he had a great interest in the whole JFK business. He said he believed that Oswald did do the shooting but that he believed there was a conspiracy, nevertheless.

I then asked him if his brother knew he was at the Symposium & he said, yes, he did know. I then asked him if his brother still kept up with all the news since the assassination & he told me, that, yes, he does. He said his brother had some personal "momentos" he was keeping but that there were other items he was releasing. I didn't have time to get Waggoner Carr's address but it probably wouldn't be too difficult to locate him. I think it would be a good idea to write him.
