Weisberg declares this is "WHITEHIX "willful suppression, manipulation and distriction of evidence disproving the official fiction in the Report and part of frameup of Lee Harvey Oswald". In his first book, WHITEWASH: THE REPORT ON THE WARREN REPORT, Weisberg insisted there was a conspiracy to kill the President, that Oswald killed no one, and will involved, probably ax a "patsy"

This same opinion is now offered by New Orleans District Attorney Jim Garrison, who also uses a word from the title of Weisberg's second book, WHITEP WASH II: THE FBI-SECRET SERVICE COVERUP. Garrison says there was a "coverup"

Among the other FBI reports in PHOTOGRAPHIC WHITEWASH are a pair showing that with a witness told the FBI she saw Uswald on the first floor of the building right before the assessination, she was not called before the Commission and this report was not printed.
