'e is flabbergasted that I have given him access to all my materials, including those things he has been officially assured do not exist. I have a prize for your collection -what doesn't exist! I have this and a few other things that were suppressed simply because it was misfiled! Thus I have a copy that could not be located when the files were purged. This books is of another really great scandel. Wait until you read it. And I have 100% of the documents quoted, more than I can use.

Until I get to New York when, hopefully we can have a relaxed meeting, I repeat that the immediate help I need is backstopping on publication, for the effort to suppress is greater than ever and I will not cross the line where I can be involuntarily bankrupted. My worth now is greater than my debts. I'll keep it that way. I must. It would cripple me to do otherwise.

I'll also be going off on a speaking tour, the details of which are not yet firm. "now enybody in San Francisco, Los Angeles or Chicago who has an organization that would like to have a speaker on this subject?
