Sorry I've not been able to reply for about two months.

One of the better ways of learning about other researchers is through their newsletters. Three are Penn Jones' The ~~EE~~ Continuing Inquiry, Penn Jones, Waxahatchie, Texas; Coverups, Gary Mack, 4620 ~~WAB~~ Brandingshire Place, Fort Worth, Tx, 76133; and Bob Cuther, The Grassy Knoll Gazette, 33 Union St., Manchester, Mass. 01944. Understand, I'm not saying I agree with what they print, say or think.

The only way you can begin to know what has not been disclosed is to make a list of what has been, and that is impossible.

The way FOIA works is you ask for specific information you want, addressing the agency that has it. So, you have to 1) know what you want and 2) describe it so the agency can understand your request and can search for it.

Some of the agencies, like the FBI and Cia, claim to have large backlogs of requests. This means that it can take more than a year before they get to any you may file.

It is not an easy or inexpensive matter for a lawyer who has had no experience with FOIA to litigate under it. He'd probably have to spend much time familiarizing himself with the case law, and by now that is extensive. It would take much time and the time of lawyers is costly.
