Dear Paul,

Today is the last of Lil's employment, so from now on my day will be less broken up, more conducive to continuous work, as in writing, where I abominate interruptions of any kind. I have spending odds and bits of time lately in trying to integrate more of the unclassified file(s) into the primitive classification I improvise as I go, with varying on much. Beginning early this m.m. I went over the file of correspondence with you and removed your memo, etc., and filed them by subject. I will refer to each below. If I fail to mention any, I hope when you have time you will send me a copy of it, or item.

It is a great tragedy that we had no integrated filing system available to us, for this makes one of the major problems of retrieval of information. As time goes on and I forget more, or am unable to keep so much in mind, this becomes more acute. I was often reminded of this as I glanced through this file.

For example, a brief Schmitt note on Gaudet; I had forgotten he had noted that Gaudet was the source on the Ruby painting purchase from Larry Borenstein. I can have my name on my interview with Borenstein. Three months ago Garrison and Mac both asked me to see Borenstein, first speaking to Bethel, who had gotten nothing from him, Tom raised as much dust I didn't. I finally met him by accident, I wish I had been able to see him alone. Someone, including strangers, was always with us. Once it was a friend of Thernley's, who I know fairly well and do not trust, not alone for this reason. His name is Jack Burnside.

Digressions: Borenstein I am told is Trotsky's nephew and may possibly be a millionaire today. In any event, the indications are he is quite rich.

From the same source, a former Bay of Pigs prisoner who has been friendly, I learn that Gaudet has seemed to be a "Luftwaisch", who folded his magazine last month. He apparently was able to get support (including financial) from Latin American governments and other sources enabling him to survive previous financial crises. (I had not known of the graduation of Harvey W. Morris (Times-Picayune 5/26/65) from West Point) but there are two similarly-named Gaudets in N.C. and when you see the complete version of COIN you'll see the address of the right one. I have added much on him. There is also a second publication with the same name as his (source ibid), the second of the Citizens' Committee for a Free Cuban Paul Bethel, editor. Formerly U.S. Embassy Havana. Further digression: same source says Nixon's great and good friend Babe Robino (approx) is a Cuban who fled 1959 with family from Cochabamba, is pro-Stalin (strongly). Robino lived with him briefly on return to U.S. Nixon has good connections, especially if he consults on policy!

In one of your unboxed memos you refer to one Hearing Gonzalez, from Beynard Johnson's book (or is it Hal's? - same). This is probably Morejon, the one of interest. He gave the wrong name when captured fearing the consequences of his past of his connections. Same source, who was with him. He is still of interest, same reason.

Your 3/7/68 memo on literature distribution: per S., there is another alternative, that it was physically impossible, as if the informant were in a car, cab or bus. I seem to recall one report in which an informant was in a bus or car. The trolley would be quite limiting, since there is but one in N.O. today, the St. Charles.

At this point, while I was changing paper, I got a phone call from Hoo. In a way it is encouraging. He is going over the files, weeding out all the leads to Constantiople, Bangkok and all the other things outside of H.Q. He is now interested in these many leads they did not end could not follow because of all the bizarre paths they took. I suppose this means Shaw-Ferrie connections. Anyway, they are finding interesting things, some possibly wrong or unimportant (like a reference to Oswald giving out leaflets on Gravier Street).

No. 6: it was much more than a few minutes. Jesse Cole had time to get back from wherever he was after his secretary phoned him and told him of the picketing, and Oswald was around for a while thereafter. He and DeBreyeys were friends. Does you say further on capture or evidence on FBI personnel viewing of picketing?

With this was an archiver's ~~interv~~ reference, no Quiregs reports. May I have a copy? I think that is quite significant for a number of reasons, only one of which is that he arranged for the INCA interest. Another is the peculiar content of the cited Reports, another is its cut-of-character aspects, etc. I was told in H.Q. that he seemed terrified when questioned there, as I recall. When the FBI went so far out of its ways to avoid giving his name or in any way identifying him, as in the Banister report (Wall), it flags our interest.

Per 44: "Another FBI informant is someone in INCA". Is this in the sense of someone regularly working with/for them or someone knowing ~~intouch~~, like Butler undoubtedly would? If not him, do you know who?

Your reference (172764) to Bartes: is it not interesting that he is not really identified? Or asked about his name in LHO's notebook when he was later reinterviewed by Wall?

12/12/67, your thoughts about the Allen-Scott Report. They undoubtedly have the Senate Internal Security, House Un-American and FBI among their sources. They have had SISCO stuff fed them.

12/21/67, "unidentified man": Do I have your letters on this? If not, may I, please?

12/17/67, Wigley: Is it not passing strange that there is no report from him on this seemingly important thing before the end of the Commission's life? Is there something not here I do not now recall? Very odd. If you have a copy of the "Cherier story, I'd like to read it carefully. I know a writer by that name. He was not unfriendly when we met. In connection with this memo, you may want to recall one I sent you after speaking to Barbara Reid about her interview with someone who knew Quigley well and a comparison between this and the report Foxley wrote. She took him along. His was entirely inadvertent.

11/29, 21, Oswald's lit. This mistake, as I believe I once wrote you, was not likely by the Government Printing Office. I have dealt with them extensively. They take no liberties, insisted, then at least, on having everything in writing. If only the fingerprints that didn't have been on it, I tend to favor the view that there may have been something a little different about that particular leaflet. The GPO would not have known to white out the thing that disclosed the switch.

9/24/67 deBrueys. Do I have a copy of that 10/26/63 report? I think not. I'd like to go over it carefully. (C01114) When you wonder about him, may I remind you (Par. 3) that he regularly attended Cuban H.Q. meetings, threatened Fene after T's testimony? Was a Cuban expert, with Cuban informants? Epstein pointing out no affidavit from him; Most likely, I think, pointed out to him by Liebaler. He didn't dig

10/29/67, Butler: May I have the Bourvine letter? That little affair may have had much more significance. If you can spare me two copies of the partial transcript, I'd like to file one with Boggs, one with Schaefer. Do you have pamphlet "Oswald Speaks"? If you can send me these, two, would you please write these two names on the back, for by the time you have time, I may have forgotten my purpose.

10/29/67, Cardell -all: Faudelation. Everything you say here is correct. Moreover, their was a kind of competition and there were some personal malices and antagonisms. Cobb, for example, vs Brent and Shaw (and Bermudez may have been less Shaw's friend than on the surface seems to be the case). There was pressure against founding IBM in the IH, I'm told. Now the IBM owns literal estate only.

9/16/68, Militant and Worker memo. Do you have the PJ article saying there were Washington officials looking forward to a successful assassination of Castro. If not, can you copy that part of the LIFE article, please?

On another subject, Bernabei is doing excellent thinking on the rifle and ballistics. His work will soon be proven, I believe. My own rifle still does not have the sight mounted because, apparently, it required a special threads for the mounting screws and the gunsmith we've determined to make it exactly the same he was reluctant to use different screws with different threads!

I have not been able to spend the requisite time on it in N.C., but I have found a woman who was at one of the parties Oswald was supposed to have attended. She thinks he was there, and it was not far from his name. The FBI really leaned on the people who were at that one. So, they have been quiet about it, afraid. It was not alone when he arrived.
