It was interesting to read about your conference with Williams and about your reservations as to whether the conference really resolved the problem. My own feeling is that if he will stay with the case you should certainly stay with him. He's a topflight lawyer and in this field as in everything else it always pays to get the best.

What's the name of your liberal Congressman? I'm asking so that if we get any communication, that is either Arnold or I, we'll know who it is who's sending it and what the source is.

The continued saga of the trials and tribulations of your book on the assassination remains fascinating. But the key thing is that it be resolved soon and that it be published. I can only hope that you face the possible embarrassment of having multiple acceptances of your offer. If that develops, we'll be able to handle it easily enough.

On the matter of the corporate continuance of the Obolensky firm, there isn't really much we can do. If the discontinuance is due to the fact that there are really no assets available for us to sue against, then suit will simply mean throwing good money after bad. If there are assets available, then the corporate discontinuance won't make any difference since it can't serve to foreclose our rights against the assets. Only a bankruptcy can serve this purpose.
