[REDACTED] DESCRIBED [REDACTED] AS A REAL GOOD MAN WHO WOULD "GO ANYWHERE AND DO A GOOD JOB". REPORTEDLY IN LATE NINETEEN SIXTYTHREE, [REDACTED] AND "OTHERS" WENT TO BIRMINGHAM, ALABAMA, WITH LOADED GUNS AND THE PURPOSE WAS "TO GET MARTIN LUTHER KING."

MOBILE REPORT DATED JUNE TWENTYFIVE, NINETEEN SIXTYFOUR, CAPTIONED "[REDACTED]" SHOWS HIS RESIDENCE AS [REDACTED] [REDACTED] REPORTED RESIDED [REDACTED] AS OF JULY, NINETEEN SIXTYFOUR.

FOR INFORMATION, MIAMI REPORT DATED JUNE FIFTEEN, NINETEEN SIXTYFOUR, CAPTIONED "UNSUBS; BOMBING OF SIXTEENTH STREET BAPTIST CHURCH, BIRMINGHAM, ALABAMA, SEPTEMBER FIFTEEN, NINETEEN SIXTYTHREE, BOMBING MATTER", ON PAGE EIGHT REFLECTS THAT PRIOR TO INTEGRATION AT THE UNIVERSITY OF ALABAMA, TUSCALOOSA, ALABAMA, [REDACTED] MET WITH GOVERNOR GEORGE WALLACCE AT MONTGOMERY, ALABAMA. [REDACTED] PROPOSED A PLAN TO STOOP INTEGRATION IN ALABAMA, SAYING HE COULD PUT FIFTY THOUSAND ARMED MEN IN ALABAMA. GOVERNOR WALLACE REJECTED THIS

PLAN, TELLING ██████████ THAT HE HAD HAD ONE OF HIS OWN. ACCORDING TO ██████████ GOVERNOR WALLACE AND FORMER PRESIDENT JOHN F. KENNEDY AGREED⁰ TO A PLAN FOR INTEGRATION AT THE UNIVERSITY DURING PRESIDENT KENNEDY'S VISIT TO ALABAMA, AT WHICH TIME PRESIDENT KENNEDY AND GOVERNOR WALLACE WERE TOGETHER IN A HELICOPTER. ██████████ DID NOT FURTHER ELABORATE ON HOW HE OBTAINED THIS INFORMATION.

██████████ SAID THAT PRIOR TO THE SEPTEMBER FIFTEEN CHURCH BOMBING IN BIRMINGHAM, A SECRET MEETING WAS HELD IN ALABAMA, LOCATION NOT SPECIFIED. ATTENDING THIS MEETING WERE ██████████, ██████████

██████████, AND ██████████. THE ALLEGED PURPOSE OF THIS MEETING WAS TO MAKE PLANS FOR THINGS TO BE DONE. ██████████ DID NOT FURTHER ELABORATE ON THIS REMARK. ██████████ SAID HE AGREED WITH THE PLAN BUT THAT HE ██████████ DID NOT PARTICIPATE IN THE CHURCH BOMBING. HE STATED THAT ██████████ AND ██████████ WERE INVOLVED, BUT AGAIN DID NOT ELABORATE AS TO THE EXTENT OF THEIR INVOLVEMENT.

██████████ STATED THAT HE WAS "HOT" IN ALABAMA AND HAD TO LEAVE. HE ALSO STATED THAT AFTER THE SECRET MEETING, ██████████ TOLD HIM HE PREFERRED ██████████ FOR ANY ACTION OVER ██████████ DUE TO THE FACT THAT ██████████ LIKES TO TALK AND DRINKS EXCESSIVELY.
