SPAS THEODORE RAIKIN INTERVIEW ED JUNE TWENTY NINE SIXTY FOUR

AT GV HOTEL, MANASQUAN, NEW JERSEY. HE VERIFIED INFORMATION
SET FORTH IN REFERENCED TELETYPE WHICH HE SAID HE PREVIOUSLY FURN-
ISHED TO SA JOHN BRODERICK OF NYO. RAIKIN ADDED THAT A TEMPORARY
EMPLOYEE OF TRAVELERS AID, A FRENCHMAN, MR. FAPIERRE APEN SPOKE
TO OSWALD ON THE BUS AFTER RAIKIN. NY ATTEMPT TO LOCATE AND INTER-
VIEW FAPIERRE IF THIS LEAF NOT PREVIOUSLY COVERED. REPORT FOLLOWS.
