Synopelsi

SPAS THEODORE RAIKIN, employed Travelers Aid, NYC, on 6/13/62 assisted OSWALD and family on arrival at Hoboken, N.J. During conversation OSWALD declared he had been U.S. Marine Guard at U.S. Embassy, Moscow, USSE. Recalled OSWALD may have said he deserted U.S. Marines rather than he was kidnapped by communist agents. However, lapse of time cannot guarantee accurate recollection. Further he believed statements made to cover fact OSWALD deserted to USSR. RAIKIN reported this matter to Travelers Aid at the time.
