As you will recall, Mr. Dwyer, Mr. Beasley, and Mr. Carlisle of this office were in Montreal and Toronto recently in their pre-trial investigation in the case of the State of Tennessee vs. James Earl Ray, set for November 12, 1968, in which James Earl Ray is charged with the murder of Dr. Martin Luther King, Jr. They brought back glowing reports of the cooperation and the treatment they received from all the persons under your command with whom they came in contact, and were high in the praise of the efficiency of your personnel.
