ADMITS KNOWING BROTHER JOHN'S LOCATION ST. LOUIS DURING PREVIOUS INTERVIEWS BUT LIED TO PROTECT JOHN'S INVESTMENT IN ILLEGAL PURCHASE OF BAR BY AN EX-CON. STATES HAS BEEN IN CONTACT WITH CAROL AND THAT UNCOOPERATIVE ATTITUDE OF BOTH CAROL AND JOHN AROSE FROM EXTENSIVE INQUIRY OF NEWS MEDIA IN NEIGHBORHOOD AND THAT BOTH WERE AFRAID OF PUBLICITY ADVERSELY AFFECTING THE BUSINESS, CAUSING THEM TO SELL OUT AND MOVE.

JERRY INTERVIEWED BY SAC AND ASAC, AT WHICH TIME HE PROMISED HIS COOPERATION AND NOTIFICATION IN EVENT OF CONTACT BY SUBJECT. SAID HE DOUBTED SUBJECT WOULD CONTACT HIM OR ANY OTHER MEMBER OF FAMILY. STEADFASTLY MAINTAINED HE NOR ANY MEMBER OF FAMILY HAS ANY KNOWLEDGE OF SUBJECT'S WHEREABOUTS, SINCE ESCAPING FROM PRISON. CLOSE AND CONTINUOUS CONTACT BEING MAINTAINED WITH JERRY RAY AND SISTER SUSAN DONIAN.
