I told the Doctor that I believe the Doctor at Marion prison (Dn. Jarvis) gave me this green Medicine-which caused the Blackouts - In an attempt to alter my Testimony In front of the H.S. C. A.

The Docter told the Judge that he Could not Made a fair report Until he gets these Marion records. a request was made to the Bureau of prisons. They Stated they would send the records that were not Harmful to me. If they, send any records et will be because it not Harmful for them. I'm well aware the type of Secret Drugs which was given to Sary Gilmore, and Charles Manson, among others—as

Well as to the Viet nam Soldiers (Such as St. Balley).

The fact that the doctor requests these records Indicates that he Might be fair-Minoled thus, I filed a letter In Court requesting a Subpers's be Issue for Dr. Jarvir, and norman Carlson (Director,

of Bureau of prisons).

Your letter mailed the 27th came here in the first mail after Labor Day, just as I was leaving for the hospital. They made some tests, and I go back week after next for arterial surgery.

I don't know any handwriting experts. I know of some, but of those of whom I know most began with the FBI. There is a woman in Boston of whom I've heard who was willing to testify in opposition to an FBI expert but I don't remember her name. There should be some in Illinois your lawyer should be able to get.

I don't know anything about fingerprint or hair experts.

If the trial goes ahead on the fifth, as you seem to say, then this can't even reach you by then.

There is nothing I can add to what I told you about your medical situation and your stubbornness in refusing to have more state and examinations because you feared they would play games with your mind.

I'll let Jim know the names of the lawyer who represents you and the doctor, in case wither one past gets in touch with him.

You told me that Mcmillan told you he is writing another book and offered you money for help. Jerry says he spoke to Priscilla and she says they are getting divorced and that he is now living in Baltimore. (About 50 miles from here but I don't expect to hear from him.) She also said she does not think he is writing any such book.

Maybe it is like the hook Jimmy says he is writing?
