I could not understand why Bud gave them to me undeveloped when in those days color film processing was done where he was but was not done here.

I did not know there were just ordinary pictures of you and nothing else.

While I was waiting for a chance to get them printed where I'd have no such concern they got mislaid. If I find an undeveloped roll of film it will have to be that one because I've not taken any pictures for a very long time and in fact have given my cameras away. While I doubt that after so long a period without being processed they are any good, if I find them I'll get them to your publisher.

You say DJ says it can't find its Foreman file. I have a hunch the FBI's might do you more good if they do not withhold what could be of use. Not that I think Percy did not make deals with DJ. I think he did. But I also think those things would not be disclosed.

If Jerry sends me his recorded voice in any form I'll save it for when I want to torture someone. Then I'd plug my ears and play it real loud!

So you are in segregation for having evil thoughts. And you say you have to be careful of what you think. Seems to me you also have to be careful about what you are suspected of thinking.

I guess things here are about as good as I could expect them to be, allthings considered. We can get used to our limitations. I can't even use the riding mower any more. About all I'm allowed to do is walk.

But anyone, there is nobody around who can tune in on my thoughts.

Or suspected thoughts.

I suppose you read Melanson's book. I suppose also that you did not learn anything from reading it.

The Kimble he makes so much out of never had any CIA connection and he tried to pull the same kind of crap with Jim Garrison on the JFK case.
