thers Backed Rebozo Loan MONDAY AUG.11,1964

WASHINGTON (AP)-Former Sen. Smathers urged the Small Business Administration to grant a nowcontroversial loan to his close friend, Miami entrepreneur Charles G. "Bebe" Rebozo, in 1962, records disclosed today.

Rebozo, whose friends also include President Nixon. obtained the \$80,000 loan despite negative recommendations from several agency staff members.

At that time, Smathers was a top-ranking Democrat on the Senate Select Committee on Small Business, which handles legislation affecting the SBA. The Florida Democrat retired from the Senate in 1968.

Rep. Patman (D-Tex.) called today for the SBA to demand immediate payment of the loan. In a House speech, Patman said Rebozo had received special favors from the SBA.
