7c FOR INFO BOSTON, ██████████ WAS INTERVIEWED IN NOVEMBER AND  
DECEMBER SIXTY THREE AND WAS AFFORDED POLYGRAPH EXAMINATION DECEMBER  
FIVE SIXTY THREE IN ATTEMPT TO EVALUATE HER STORY THAT WHILE EMPLOYED  
BY RUBY IN NINETEEN SIXTY ONE SHE ATTENDED MEETINGS AT DALLAS, TEXAS  
CONCERNING RUNNING GUNS TO CUBA, AT WHICH MEETINGS RUBY WAS ALSO  
PRESENT. HER STORY WHEN INTERVIEWED WITH THE POLYGRAPH VARIED FROM  
7c THAT SHE ORIGINALLY FURNISHED. ██████████ STATED SHE ATTEMPTED  
SUICIDE NINETEEN FIFTYSIX FOLLOWING WHICH VOLUNTARILY COMMITTED SELF  
TO PSYCHIATRIC WARD NORTH HAMPTON STATE HOSPITAL, MASSACHUSETTS,

BEING DISCHARGED AFTER TEN DAYS OBSERVATION. [REDACTED] ADMITTED SEVERAL ARRESTS, INCLUDING ARREST BOSTON NINETEEN SIXTY OR SIXTYONE FOR PROSTITUTION, TWO HUNDRED DOLLAR FINE. CLAIMED HAS SUFFERED FROM CHOREA (ST. VITUS DANCE) SINCE AGE EIGHT, EXTREMELY NERVOUS. CURRENTLY UNDER PHYSICIANS CARE FOR LOW BLOOD PRESSURE AND TAKING METHADRENE. RESULTS OF POLYGRAPH EXAMINATION INCONCLUSIVE DUE TO PAST MEDICAL HISTORY AND USE OF DRUGS, HOWEVER SIGNIFICANT EMOTIONAL RESPONSES RECORDED BY POLYGRAPH, LEAD EXAMINER TO BELIEVE HER STORY CONCERNING THE CUBAN ARMS MEETINGS IS UNTRUE. THE EXAMINER WAS OF THE OPINION SHE HAS TENDENCY TO DELUSIONS OF GRANDEUR. DURING INTERVIEW SHE CLAIMS ACQUAINTANCE WITH MRS. JACQUELINE KENNEDY PRIOR TO HER MARRIAGE. ALSO CLAIMS SHE KNEW AND DANCED WITH SENATOR EDWARD KENNEDY DURING HIS ATTENDANCE AT HARVARD AND CLAIMS SHE WAS EMPLOYED AS LOBBYIST FOR LIQUOR INTERESTS AT MASSACHUSETTS LEGISLATURE IN NINETEEN SIXTY. EXAMINER COULD NOT EVALUATE WHAT PORTION IF ANY OF HER STORY WAS TRUE.
