PCI RECALLED THAT HE MET WITH CUSUMANO A DAY OR TWO AFTER CUSUMANO RETURNED TO ST. LOUIS FROM DALLAS AND LEARNED THAT CUSUMANO AND THE OTHER ABOVE MENTIONED INDIVIDUALS HAD ALL BEEN ARRESTED BY THE CALLAS POLICE DEPARTMENT SHORTLY AFTER CUSUMANO HAD ARRIVED IN DALLAS. HE RECALLED THAT ON AT LEAST ONE OCCASION SHORTLY AFTER CUSUMANO-S RETURN THAT HE WAS AT CUSUMANO-S RESIDENCE IN ST. LOUIS WHEN JOE SIMON WAS THERE AND CUSUMANO AND SIMON MENTIONED THE NAME EDDIE MARK AND WERE REFERRING TO EACH OTHER IN JEST AS QUOTE

EDDIE UNQUOTE. PCI STATED THAT CUSUMANO HAS HAD THE HABIT OF LONG STANDING OF USING THE NAME OF A PERSON THAT HE KNOWS WHEN SOME REASON EXISTS FOR HIM TO USE A PHONY NAME. PCI FURTHER STATED THAT IN CONVERSATION WITH CUSUMANO PRIOR TO THIS MEETING THAT HE HAD LEARNED CUCUMANO WAS ACTUALLY ACQUAINTED WITH AN EDDIE MARX WHO WAS ACTUALLY RESIDING IN ST. LOUIS. THIS EDDIE MARX UNKNOWN TO PCI.

PCI HAS NO KNOWLEDGE THAT THE NAME MARK OR MARX MIGHT HAVE BEEN USED BY ANY OF THESE PEOPLE IN DALLAS. DURING PCI-S CONTACTS WITH THESE PEOPLE FOLLOWING THEIR RETURN FROM DALLAS HE HEARD NO CONVERSATION REGARDING JACK RUBY OR ANY SITUATION REGARDING THEIR HANDLING GUNS FOR CUBA.

SAN FRANCISCO, IF NOT PREVIOUSLY DONE, REQUESTED TO ADVISE DALLAS REGARDING ANY INFORMATION AVAILABLE FROM NANCY ELAINE PERRIN AS TO FOLLOWING--

NATURE AND EXTENT OF PERSONAL ASSOCIATIONS, IF ANY KNOWN TO PERRING, BETWEEN RUBY AND THE SYNDICATE MEN SHE SAW IN RUBY-S CLUB. HOW SHE RECOGNIZED OR IDENTIFIED THEM AS SYNDICATE MEN. WHETHER EDDIE MARX AND THE OTHER ST. LOUIS

AND CHICAGO SYNDICATE MEN SHE SAW IN RUBY-S CLUB WERE INCLUDED ALSO AMONG PERSONS ATTENDING FOUR MEETINGS WITH RUBY IN DALLAS APARTMENT WHEN MATTER OF GUNS FOR CUBA WAS DISCUSSED. WHETHER THERE IS ANY CONNECTION KNOWN TO PERRIN BETWEEN THE MATTER OF GUNS FOR CUBA AND PRESENCE OF SYNDICATE MEN IN RUBY-S CLUB. DATES OR APPROXIMATE DATES OF THE FOUR MEETINGS WITH RUBY AND THE OCCASION WHEN PERRIN SAW EDDIE MARX AND OTHER SYNDICATE MEN IN RUBY-S CLUB. HOW MANY PEOPLE WERE INCLUDED IN THE VARIOUS GROUPS PERRIN REFERS TO. DESCRIPTION OF EDDIE MARX AND OTHER PERSONS RECALLED BY PERRIN. ANY OTHER ESSENTIAL DETAILS OBTAINED IN RECENT CONTACT BY SAN FRANCISCO WITH PERRIN AS REQUESTED BY DALLAS IN REFERENCED DALLAS TELETYPE.

DALLAS REQUESTED TO EVALUATE ALL PERTINENT INFO AND CONSIDER FORWARDING PHOTOGRAPHS OF EGGERT ET AL IN DALLAS POSSESSION TO SAN FRANCISCO FOR DISPLAY TO PERRIN TO DETERMINE WHETHER ANY OF THEM IS IDENTICAL WITH EDDIE MARX OR OTHER PERSONS TO WHOM SHE HAD REFERRED. IMMEDIATE WHEREABOUTS OF EGGERT ET AL UNKNOWN TO ST. LOUIS EXCEPT THAT [REDACTED]
