SUBJECT: ASSASSINATION OF PRESIDENT
JOHN F. KENNEDY

AUSA BARNEY H. TIMMINS advised he received the following information from USA H. BAREFOOT SANDERS:

LARRY HOCKBERG, an attorney, office telephone RI 8-4506, home telephone CH 7-6646, contacted USA SANDERS and telephonically advised him that he, HOCKBERG, has a client who works across the street from Texas School Book Depository and parks her car near there. The client, a white female, said she saw car with two men in it last Tuesday, 11/19/63, near the Texas School Book Depository. One of the men got out and took a rifle from the trunk of the car and handed it to the other man. She thinks one of the men may have been OSWALD. HOCKBERG said the client will not talk to the Dallas PD, is in fear of her life, but HOCKBERG may be able to talk her into furnishing information to the FBI.
