I am sending you a few items of interest for yourself if you consider them important. The copy on George Lincoln Rockwell's car, perhaps, answers some questions about who financed Rockwell. A man named Arrowsmith is mentioned as the "fat cat", also a name Allen (who is of special interest to me. I will get to later.) Rockwell's cryptic remarks about Arrowsmith in the, Page 102, "THEY'RE COOPER'S. THEY WANT A FRONT MAN, AND I'M HIM, BUT THEY'VE HAD TO FIND SOMEONE TO WAGONER WHO HE MEANT BY THEY" and minor degree confirm my suspicion. Rockwell was also

You wanted to know what I think there is a possibility, two men were right in suspecting an agent, if not a silent Nazi, then of a man of master. He worked for Wallace Allen in Atlanta in printing and advertising line. There is mention of Rockwell's work for The National States Rights Party (1957) one of the departed Nazis, Schnapper terms, held a more recent job in the Strategic Army Map Service. (Page 104)

A few other items are here enclosed in a separate envelope. Three photographs ripped from a magazine, but unmarked as far as issue or page. A letter writer to Time Magazine Sept 15, 61 wrote, "A few
days after Rockwell was murdered": "MR. George Lincoln Rockwell
was not a common hate-monger or backward bigot. He was a man
of refinement of forensic eloquence and razor-sharp intelligence
of which had been honed to a hair thin cutting edge. His
stature emitted strength as well as fear. The real tragedy of
Rockwell's demise is that such quality and potential leadership
was befouled by a twisted alignment with a twisted
ventriloquial psychopath, and murdered in a cowardly
surrender conviction that if this man had not perished, the
belonged enclosed in the morass that is the mass mind of
the lowest humanism with excellence as a leader, diplomat,
perhaps a cabinet officer. His combat record attested to his
capabilities."

Please comprehend that in no way can I be said to
endorse the tenets of Nazism. I reject the entire Nazi ideology
and the actions of Commander Rockwell had done the same.

Before he was killed I heard Rockwell's speech on
engineering against the Surgeon General, I believe from the

He received a 30 day jail term and a \$250 fine. Later, at a ceremony at ANP headquarters in Birmingham, he was awarded a medal for his "quest for the truth".

Then March 20, 1963, in Miami, the ANP ~~held~~ held a meeting at the Fontainebleau Hotel, carrying such signs as "White Terrorists", and "FORGET ISRAEL, FREE CUBA".
