Dear Mr. Weisberg:

I am sending you a few items of info for yourself if you consider them important. The issue on George Lincoln Rockwell can, perhaps, answer some questions about who financed Rockwell. A man named Cervosmith is mentioned as the "fat cat", also a man Allen (who is of special interest to me - I will get to him later.) Rockwell's remarks regarding his motivation, page 102, "THEY'RE COURSES. THEY WANT FRONT MAN, AND I'M HIM, BUT THEY'LL HAVE TO PAY ME" causes me to wonder who he meant by they. A minor degree confirmation of my suspicion - Rockwell was no

You wanted to know what I think now, there is a possibility, two men were right in suspecting an agent, of not "Soviet" Nazis, then of the "Red Master". He worked for Wallace Allen in a "news printing and advertising line" There is mention of Rockwell's link to The National States Rights Party (103) one of the depicted Nazis, Schaeffer terrorist held a most notorious job in the Strategic Army Map Service (page 104)

A few other items to have checked or research:  
1. escape Three Photographs ripped from a magazine or magazine, but unmarked as far as issue or date. I found them in some of the "junk" and debris in my room. ## MORE ON ROCKWELL

A letter written to Time Magazine Sept 15, 6 days after  
Rockwell was murdered: "SIR: George Lincoln Rockwell  
was not a common hatemonger or backwood bixot. He was the  
embodiment of forensic eloquence and Nazi-style pathology  
of which had been honed to a fine, thin cutting edge. His  
stature emblazoned strength as well as fear. The real Tragedy is  
Rockwell's demise is that such quality and potential leadership  
will be forever lost by a twisted alignment with a bunch of  
vendetta psychopaths and mass killers. A silent judgment  
such as conviction that if this man had not been killed he would  
have escaped to the masses that is, The Masses would not  
have joined him with enthusiasm and dedication.  
Perhaps a Cabinet officer. His combat record attests to the point."

"Please comprehend that in no manner is it condoned  
to endorse the Tenets of Nazism. I reject the entire page of  
naziism with Commander Rockwell has done the same."

Before he was killed it bears Rockwell's signature  
copy bearing across the page was, "I believe firmly in our

He received a 30 day jail term and \$100. later, at a ceremony at ANP headquarters in Atlanta, he was awarded a medal for his "qualit & h. fin."

Rockwell was selling a 99¢ record entitled "HATEFUL HIT RECORD", Sung by The 3. bigots.

A "BOAT TICKET TO AFRICA" - According to Rockwell can be heard to "Your favorite Nigger."

The end of the Esquire article has something about Rockwell.

One Robert Lloyd was well known for his antics on the floor of the House of Representatives. He came in blackface and charcoal, yelling "I SUE DE MISSISSIPPI Delegates".

These grown men playing little kid games up there - all of us as Amusing - Rockwell himself said it was a major source of this type of humor. His HATE MONGER convinces me of his utter silliness, Plus his publications with titles like the following: "Niggers! you are a JEW! Communism is IRISH! PROOF THAT COMMUNISM IS A PLANT!"

I have even heard he had special Envelope paper with FDR'S image imprinted on each sheetnote.

Now, however, I must get into something more serious.

In July, 1962 Rockwell sneaked to England for a meeting at the World Union of National Socialists of London, after it was over, Butcher Yard, Special Branch, London. He managed to check them for some change. British newspaper reported him in Canada, July 1962, later, finally caught in Belgium with him - and he was held for several days in enough time to get out of the country.

In August, 1962, The month of Hanukkah, George Lincoln Rockwell made a trip to Canada, claiming he was seeking a freedom party branch, Nazi Party. He stayed at a Montreal hotel, ~~the~~ ~~where~~ his true identity was eventually discovered and he was evicted.

According to Harrison, Montreal is the central base.

the suspects, printing salesman Wallace Allen, officers found a  
famous letter from Rockwell, then an unknown extremist,  
in Washington. The letter mentioned plans for a 'Big Blast'  
"Distract" "DON'T LET THE ARABS GET IN"~~THE ACT~~

"Questioned by FBI agents, Rockwell said the 'big blast'  
was an anti-Jewish picketing demonstration planned,  
he said. He was less specific about his reference to the swastika  
on his home. C-men found a Swastika Plan and Baiter -  
The Literature for distribution By THE NATIONAL STRATEGIC  
ANTS, PRETTY AND OTHER HATE GROUPS.

"Significantly, all four men indicted for the attempted  
murder were members of the NSRP. Two of the four

also belonged to the Ku Klux Klan."

Author Mistil also mentions casually his interview with Rockwell. Rockwell turned silent when he was asked about his connections in Cairo. Mistil claims to have learned Rockwell was in touch with DuTrot & Haessner & Nequin in New York and Washington." Other investigators, according to Mistil, "had a report Rockwell's anti-Semitic publishing business was bankrolled by The United Israel Republic and The Crab League."

To Montreal

### GARRISON'S MOST DANGEROUS CONSPIRACY
