I don't whink you have a terrible knowledge of history(current), as you put it. You were simply of an age when you had to be unaware in and there is no honesty in the teaching of it, for the teachers could not survive it if they understood it. As you have have seen, the rbightest present themselves as not understanding, and when they were part of it, who can criticize the humble lehrer. On the wall speech, suppose we compromise, eliminate turning point and beginning of his education, and substitute the beginning, limited as it was, of his understanding?

If you doubt my interpretation of the presence of our troops in Europe at the beginning to be to prevent revolutionary change, do you for a moment that the most desolated country in the world, the one with by far the heaviest human loses, was in a position to launch any adventure, even if it so desired? Was Germany about no invade anybody? Italy? Roumania?Poland? Czech? Hungary? Spain? What else could it possibly have been? And since then, a means of keepin things after and the wareconomy going. Meanwhile, this would seem to indicate that a fat letter did not reach you. I have no idea what else was in it. Nichols decision: he did lose, and I hape he doesn'r carry it any further for a combination of reasons. He had a high-priced, smooth-writing law firm whose basic research was inadequate and he, apparently, had done none. If and when you see it, as you will, compare what they havem for example, on what constitutes a "record" under the law and what I have in 2569-70, and I'm not a lawyer and that work had the benefit of no lawyerss touch or even advice. He was wrong, there is contrary and binding decision, but it does tend to have a slightly broadening influence, for there are, without was doubt, cases where one can't know which agency to sue. He had a simple way around this, but neither he nor his lawyers read the AG's memo on the law. Worried as I am about anything he is connected with and more, about specifics of each of his suits (I wasted an enormous and unthanked labor on his first, enough to have written a book in that time), I wasn't about to help him get into coirt and there get a binding and damaging decision after full hearing. I had a fine surprise last night, a phone call from a California friend, a reporter, who is giving me a tiny casette recorder for my trips, of which there should be more but of which there is no immediate prospect, those on whose behalf I should make them being reluctant to use the money this way and I not having it. But w ithout the trips I'll have good use for it, as when I can dub out short sections of interviews and other tapes and put them on individual, times timed casettes, for radio and TV use, for backgrounding reporters, etc. (Two major media elements have assigned F-U to their D.J reporters).
