I called the book reviewer on Bulletin who told me that he had heard of your book but decided not to review it. I told him of the rave reviews it had gotten already and a little of the explosive material in it, strongly recommending that he read it. He said he'd look into it.

I submitted a request that our Bokkstore stock F-U and was told that it already had 5 copies. Will check tomorrow. I also put in a form to order it for our school library, which has your other things in the Law branch.

Of course, I will want a copy. If I can come soon as I hope, then we can transact that business in person and avoid mailing costs.

The Joe Goulden article is enclosed, minus 2 inconsequencial paragraphs which could not fit. The info you wanted is included.

There are some things from the JFK press conference I'd like to discuss, including what happened w Cambodia and the Bargbioorn case, which I had largely ignored until you said that he was an agent. Do you have the date of the NYT which reports JFK saying he'd splinter the CIA? You imply this came from that case.

Your note on the large amount of JFK policy material you now have is encouraging. I look forward to examining it when I am there. You say that we both have permission to copy. Perhaps since I will probably want much for my files I could handle the cost for your copies as well, if you want them.

Your letter to Dick which mentions possibility of postal snooping comes appropriately at a time when my paranoia of such things grows.
