I'm awfly sorry to hear about your thumb. How did it happen? I hope you're doing well.

As you understand, I was NMAX not aware you didn't want said over the phone what Jerry asked me to tell him and with which I complied. I should have exercised better judgement myself.

On the thing with Wecht, I've been giving it serious thought all day since I read your recent numerous mailings. First of all, it is apparent to me that you will not get through to Cyril, especially with the approach you have taken all along, which has been to be totally ambiguous and demand "THINK." Unfortunately, nobody is thinking like you, especially people who do not understand the position of the Kennedies and view tham as real suppressers. Last year, I could condone that approach. I do not now, not when, if your position proves correct we may be severely damaged, it is crucial for others to understand what you are saying. You may not want to explain it over the phone, but at least in writing.

But even if Cyril does read you clearly, it seems unlikely to me he will heed you. In short, I think there is no stopping him now. Furthermore, I got the impression when I was sucked into the Ned affair that your relations with Wecht had been all but ruined. It occurred at the same time, and I caught only a little of it from Jerry, who was in touch with Sylvia. I ask myself if some saving compromise is not possible? If Cyril gets to see the films, it seems your chief concern, other than what it will deny you, is that it will be used to get all those responsible off the hook by saying the Kennedys suppressed all this.
