- 2. You say "some documents have been withheld from disclosure." Please provide a list of exactly what documents are being denied to me, the number of pages in each, and the specific reason for withholding.
- 3. You invoke the investigatory file exemption. Please tell me what law was being enforced that now qualifies these records for "law enforcement purposes" protection.
- 4. Only one record that you sent contains a deletion: Mr. Weisberg's letter of 6/2/69 to Mr. Rowley. What is the specific reason for that deletion?
- 5. Mr. Kelley forwarded the "memo of transfer" to Dr. Rhoads at the Archives by letter dated March 6, 1970. Why was I not sent a copy of that letter?
- 6. You have twice now incorrectly addressed letters to me, first to Apt. "B-27" and then "B-24." My correct Apt. number is B-29. I would appreciate this simply œurtesy.
